Official Rules & Conditions of Eligibility

Win an MGM Movie Premiere Experience Trip, MGM Home Theatre Package or Cinema Cash Movie Tickets for a Year!

OVERVIEW:

Beginning November 2, 2009, the Maryland State Lottery Agency ("Lottery" or "Maryland Lottery") is giving Lottery players an opportunity to enter the Cinema Cash 2nd Chance Contest for a chance to win one of five (5) great prizes simply by sending in two (2) non-winning Cinema Cash (Game #787) scratch-off tickets.

MGM Movie Premiere Experience: One (1) winner will win a trip for two (2) to an MGM Movie Premiere of their choice (from a list of options in the United States) including two (2) tickets to the MGM Movie Premiere, airfare for two (2) from BWI to the US Premiere destination, 5-day/4-night accommodations, private sedan transfers to and from the airport to and from the hotel, deluxe dinner for two (2), a \$300 gift card to a salon for hair/make-up, as well as a \$1,000 gift card for shopping. Estimated tax withholdings paid* (*see Claiming section). The total value of the MGM Movie Premiere Experience will depend on the US Premiere destination selected by the winner. See Claiming section for more information.

MGM Home Theatre Package: One (1) winner will win 25 MGM movies, one 42" Plasma HDTV, a Home Theatre Sound System, to include a 5-DVD/CD changer, five (5) surround speakers and a powered subwoofer. Estimated tax withholdings paid* (*see Claiming section). The MGM Home Theatre Package prize has a total estimated value of \$1,700.

Cinema Cash Movie Tickets for a Year: Three (3) winners will each win a \$1,000 gift card.

HOW TO ENTER:

To enter the Cinema Cash 2nd Chance Contest, send in any two (2) non-winning Maryland Lottery Cinema Cash Scratch-Off tickets (Game #787) with your name, address (and, preferably, phone number and/or e-mail address) to:

Entries must be mailed in an envelope no larger than 4-1/2" by 9-1/2" in any direction, and all entries must contain a Maryland postmark. Entries submitted should list one name only, or the Lottery will choose which name is the winner. No other tickets other than non-winning Maryland Lottery Cinema Cash Scratch-Off tickets (#787) may be used to enter this contest. Cinema Cash Scratch-Off tickets originally winning on the ticket itself are not valid entries and will not be considered. Each mailing will be considered as one entry, even if the mailing contains more than two (2) non-winning Cinema Cash (#787) Scratch-Off tickets. If more than two tickets are enclosed in one envelope, the Lottery will randomly choose two.

Drawing date and entry deadline to be announced on Lottery's website. Entries must be received by 10 AM on the announced entry deadline to be eligible for the Cinema Cash 2nd Chance Contest.

To enter, you must be 18 years of age or older and you must have a legal presence in the United States. You may enter as often as you wish; however, 1) you may only win once, and 2) only one person per household (anyone living at the same address) may be selected as a winner. (Players and winners are sometimes referred to as "you" and "your" and "participant" or "participants".) This second chance contest is governed by these Official Rules and Conditions of Eligibility. This is a bonus drawing.

The Lottery reserves the right to reschedule any times and dates regarding this 2nd chance contest, if necessary, without advance notice. In the event the Lottery receives an excessive number of entries for this 2nd chance contest, the Lottery reserves the right to conduct one or more random pre-drawing(s) to determine the final entries for the contest drawing. A "drawing" may include any random selection event.

CLAIMING:

The drawing date and entry deadline are to be announced. All Cinema Cash 2nd chance winners will be notified following the drawing via courier and/or telephone and/or email and/or certified mail to confirm eligibility. You will be advised, at the time of notification, of claiming procedures and claiming deadlines. In the event a winner cannot be confirmed or qualified or has not submitted required claiming documentation within 15 business days after the drawing, the Lottery may select an alternate winner.

If you are one of the five (5) Cinema Cash 2nd Chance prize winners, you must claim your prize in person by 4:30 PM on the announced claiming deadline at the Maryland Lottery Baltimore Customer Resource Center, Montgomery Park Business Center, 1800 Washington Boulevard, Suite 330, Baltimore, MD 21230. Winners must complete a Lottery Claim Form, including Social Security number (SSN), and must provide proof of your SSN and must furnish photo I.D. proof of being at least 18 years of age and of legal presence in the US. Allow a minimum of 10 business days after claiming for notification (via courier) by PBLP regarding the fulfillment of the MGM Movie Premiere Experience prize and the MGM Home Theatre Prize Package. Prizes cannot be transferred or assigned, except as otherwise provided in these Rules. Actual prizes may vary, depending upon availability.

* Pollard Banknote Limited Partnership and Pollard (U.S.) Ltd., (collectively, "PBLP") will pay the required estimated State and Federal tax withholdings on the MGM Movie Premiere Experience prize and on the MGM Home Theatre Prize Package at the required withholding rate(s). Further amounts may be owed. The payment of tax withholdings by an entity other than the winner could result in additional Federal and State tax liability being due from the winner. Winners are responsible for all other taxes, including income taxes, in excess of withholdings paid by PBLP. The entities responsible for providing the various prizes will provide appropriate tax forms. You may receive multiple W-2G or other tax forms.

Claiming: MGM Movie Premiere Experience:

The MGM Movie Premiere Experience prize winner will be given a copy of the completed claim form, and instructions for obtaining your prize. You must retain both a copy of your Claim form and instructions for obtaining your prize, and follow the instructions to confirm any deadlines. Once you have claimed your prize, your name and information will be given to PBLP, who will notify you and proceed with coordinating and managing the fulfillment of the MGM Movie Premiere Experience. Notification by PBLP will be sent via courier with proof of receipt requested. Prize fulfillment will include the scheduling and coordination of all travel arrangements. Winner must timely advise PBLP so that flight reservations can be scheduled. Flight reservations must be made within 12 months of winner notification (via courier) in accordance with airline schedules and in accordance with the MGM Movie Premiere dates. Otherwise, the MGM Movie Premiere Experience prize is forfeited.

Winner and guest must travel together. If winner and/or guest fails to arrive at any designated time of departure or event associated with the MGM Movie Premiere Experience prize, that aspect or portion of the prize shall be forfeited and winner and/or guest is responsible for being present at the next designated location or event at his/her own expense. The MGM Movie Premiere Experience prize is not redeemable for cash.

The winner understands and agrees that air travel and movie premieres are subject to forces beyond the control of the Lottery and PBLP, and therefore, the Lottery and PBLP shall not be subject to any liability as a result of the inability to fulfill the prize or any portion thereof. The winner further understands and agrees that the Lottery reserves the right in its sole discretion a) to substitute a prize of equivalent value for the MGM Movie Premiere Experience in the event that circumstances warrant this change, including the right to substitute an MGM Movie Premiere Experience of equivalent or higher monetary value for any one of the originally proposed MGM Movie Premiere Experiences if one of the originally proposed MGM Movie Premiere Experiences becomes unavailable, or b) to reschedule the fulfillment of the MGM Movie Premiere Experience. The winner may not request a substitute or equivalent prize, and may not redeem the MGM Movie Premiere Experience prize for cash. The Lottery has no liability or responsibility for any loss, theft, or damage to all or any portion of the prize.

The MGM Movie Premiere Experience prize cannot be transferred or assigned without the express written consent of the Lottery.

Claiming: MGM Home Theatre Prize Package:

The MGM Home Theatre Prize Package winner will be given a copy of the completed claim form, and instructions for obtaining your prize. Once you have claimed your prize, your name and information will be given to PBLP, who will notify you and proceed with coordinating and managing the fulfillment of your MGM Home Theatre Prize Package. Notification by PBLP will be sent via courier with proof of receipt requested. The winner further understands and agrees that the Lottery reserves the right in its sole discretion a) to substitute a prize of equivalent or greater monetary value in the event that circumstances warrant this change, or b) to reschedule the fulfillment of the prize. The winner may not request a substitute or equivalent prize and may not redeem the prize for cash. In the event that the winner's MGM Home Theatre Prize Package is received in damaged or defective condition, notify PBLP. PBLP will have no liability or responsibility for loss or theft of the MGM Home Theatre Prize Package after receipt by a winner. The Lottery has no liability or responsibility for any loss, theft, damage, or defective condition of or to all or any portion of the MGM Home Theatre Prize Package at any time.

Claiming: Cinema Cash Movie Tickets for a Year:

Neither PBLP nor the Lottery will pay tax withholdings on the Cinema Cash Movie Tickets for a Year prizes. Winners are responsible for all tax liabilities, including income taxes, on the Cinema Cash Movie Tickets for a Year prizes. Allow a minimum of 15 business days after claiming for delivery of the \$1,000 gift card prizes.

OTHER OFFICIAL GAME RULES:

By submitting an entry for this Cinema Cash 2nd Chance Contest, you consent and agree to the following: a) to publicity and to have your name, photo, and/or hometown aired on TV, radio, text messages, social media such as Facebook, Twitter and YouTube and other media, and in other publicity, as well as used in Lottery publications and advertisements, Lottery mailings, and/or other Lottery-related activities, including mailing lists, b) to participate in a check presentation ceremony as determined by the Lottery, c) to sign news and press release forms, and d) to sign waivers and releases of all liability and to ensure that any guests of winners also sign waivers and releases of all liability, including any guest of the winner of the MGM Movie Premiere Experience prize.

- agree MSLA is not responsible for any negligence of any person, or for any claim, liability, injury, property loss, or other damage of or to players, participants, winners, guests and/or their family members, or other persons arising directly or indirectly from or in connection with either the use or misuse of prizes awarded or with participation in this contest or in any event or occurrence related to this contest, including, but not limited to, claims for damage to property, for personal injury or death, or claims based on defamation, rights of privacy, rights of publicity or cash or merchandise delivery;
- acknowledge and agree that MSLA has neither made, nor is responsible or liable for, any warranty, representation or guarantee, express or implied, in fact or in law, relative to any prize, including but not limited to its quality, mechanical condition, or fitness for a particular purpose;
- understand and agree that the Lottery reserves the right in its sole discretion to substitute a prize of equivalent value or higher for any or all of the prizes in the event that circumstances warrant this change, and that winners may not substitute a cash equivalent or other substitute for any of the Cinema Cash (Game #787) 2nd Chance Contest prizes;
- understand and agree that the Lottery does not endorse any company by providing a prize from that company; and
- understand and agree that the Lottery is not liable or responsible for any loss, theft, damage, or destruction to or of all or any portion of any of the prizes, whether during delivery or at any other time.

The probability of winning a Cinema Cash (Game #787) 2nd Chance Contest prize will be determined by the number of entries received but will not exceed approximately 1 in 879,135. The Maryland Lottery is not responsible for names announced or published in error.
