

SET for LIFE 2**\$1,000 A Week* Top Prizes and Top Prize Drawing (TPD)
Official Rules and Conditions of Eligibility**

*The Set For Life 2 Win \$1,000 A Week prizes (all “Match 3 like amounts” and the one “Collect to Win”) will be paid in an annual annuity of 20 equal payments unless the winner selects the “cash” payment option within 60 days after the date that the winner claims the top prize. The Cash option amount will be less than the annual annuity amount. The Set For Life 2 Top Prize has an annuity value of \$1,040,000. The cash option value will be determined at the time of redemption.

COLLECT TO WIN

Players collecting all four (4) of the “C”, “A”, “S” and “H” symbols from the Set For Life 2 Scratch-Off tickets (Game #698) will be eligible to enter the Top Prize Drawing for a chance to win the Set For Life 2 Scratch-Off Collect to Win Top Prize of \$1,000 a week* for 20 years.

HOW TO ENTER THE “COLLECT TO WIN” TOP PRIZE DRAWING:

To enter the Collect to Win Set For Life 2 Top Prize Drawing, you must collect the corner stubs of four (4) Set For Life 2 tickets displaying each of the “C”, “A”, “S” and “H” symbols and mail them, along with your name, address (and optionally, phone number and/or e-mail address) to:

The corner stubs with the “C”, “A”, “S” and “H” symbols may come from winning and non-winning tickets. Entries must be mailed in an envelope no larger than 4-1/2” x 9-1/2” in any direction and must contain a Maryland postmark. Each mailing will be considered as one entry, even if more than one set of Set For Life 2 Scratch-Off ticket “C”, “A”, “S” and “H” symbols is enclosed. This Top Prize Drawing is not a 2nd Chance Drawing and no tickets other than Set For Life 2 Scratch-Off tickets may be used to enter this drawing. The winning entry will be selected in a random drawing. A drawing may include any random selection event.

**The Set For Life 2 Top Prize Drawing
will take place at least 182 days after the announced end of the game.
Entry deadline and drawing date will be announced. It is the player’s
responsibility to determine when those two dates are once they are announced.**

To enter this Top Prize Drawing, you must be 18 years or older, and you must be a legal resident of the United States. This drawing is governed by these Official Rules and Conditions of Eligibility.

The Lottery reserves the right to reschedule any times and dates regarding this drawing, if necessary, without advance notice. In the event the Lottery receives an excessive number of entries for this drawing, the Lottery reserves the right to conduct one or more pre-drawings to determine the final entries for the Top Prize Drawing.

CLAIMING THE “COLLECT TO WIN” TOP PRIZE:

The winner of the Collect to Win Set For Life 2 \$1,000 A Week Top Prize Drawing will be notified via telephone and/or certified mail to confirm eligibility. The winner will be advised, at the time of notification, of claiming procedures. The \$1,000 A Week Top Prize must be claimed in person at the Maryland Lottery Baltimore Customer Resource Center, Montgomery Park Business Center, 1800 Washington Boulevard, Suite 330, Baltimore, MD 21230. Winners must complete a Lottery Claim Form, including Social Security number (SSN), and must provide proof of their SSN and must furnish photo I.D. proof of being at least 18 years of age. **Prize must be claimed within 182 days after the drawing.** Allow a minimum of 15 business days after the Lottery receives a claim for the Set For Life 2 \$1,000 A Week Top Prize for delivery of payment (first annuity payment, or, if selected, “cash” payment).

Prizes cannot be transferred or assigned except as provided by law. All applicable state and federal taxes, and any child support arrearages, criminal restitution owed, and other outstanding state debts will be withheld from the Top Prize. Further amounts may be owed. Winner is responsible for all taxes, including income taxes.
