

# Maryland Lottery® Pick 3 for Free\* 2nd Chance Promotion Drawing Rules

## OVERVIEW:

Beginning any time on July 1, 2016, until 11:59:59 PM on July 31, 2016 ("Promotion Period"), players can participate in the Maryland State Lottery and Gaming Control Agency ("Lottery" or "Maryland Lottery") Pick 3 for Free 2<sup>nd</sup> Chance Promotion ("Promotion") for a chance to be selected as one (1) of eighty (80) winners to win the cash equivalent of a \$1 Midday Pick 3 or Evening Pick 3 ticket for a year.

To participate, enter at **mdlottery.com/rewards** one (1) winning or non-winning Lottery Pick 3 terminal ticket ("Ticket" or "Tickets"). Tickets must be purchased and entered during the Promotion Period in order to be eligible for entry into the Promotion.

Entries must be entered by 11:59:59 PM Eastern Time on the last day of the Promotion Period to be included in the drawing. (In these rules, all times are Eastern Time.) A drawing may include any random selection event. This is a bonus drawing with bonus prizes.

Internet access and a valid email address are required to enter this Promotion and its drawings. Mailed entries will not be accepted. You may enter as often as you like; however, you may only win once. One Ticket equals one entry into the Promotion. YOU DO *NOT* NEED TO KEEP YOUR ORIGINAL TICKET IN ORDER TO CLAIM YOUR PRIZE IF YOU WIN. (Players and winners are sometimes referred to as "you" and "your".) A Ticket may only be used to enter one time.

Promotion Period: July 1, 2016 – July 31, 2016 Drawing Date: August 1, 2016 Claim Date for Winners: By 4:30 PM, November 1, 2016 Claim Date for Alternates: By 4:30 PM, December 1, 2016

#### \*Prize:

- Forty (40) winners will be selected to receive the cash equivalent of one (1) Midday Pick 3 ticket that contains a one dollar bet per day for a year, valued at \$365 per winner.
- Forty (40) winners will be selected to receive the cash equivalent of one (1) Evening Pick 3 ticket that contains a one dollar bet for a year, valued at \$365 per winner.

Winners will be announced at mdlottery.com.

#### CLAIMING:

You will be advised, at the time of notification, of claiming procedures and reminded of the claiming deadlines. Winners must claim by 4:30 PM on the claim date listed above. If more than one name is provided on any winning entry, the Lottery will choose which is the winner.

- 1) Winners may claim your prize as follows:
  - a. In person at the Lottery's Baltimore Customer Resource Center, Montgomery Park Business Center, 1800 Washington Blvd., Suite 330, Baltimore, MD 21230;
  - b. Through the mail at the address provided above; or
  - c. Through email or facsimile transmission. An email address and/or fax number will be provided upon request.
- 2) Allow a minimum of 15 business days after the Lottery receives a claim and proof of eligibility for delivery of the prize.

- 3) Prizes claimed through the mail, email or facsimile transmission will be mailed once winner's eligibility has been fully validated. If a winner has been disqualified, or by the relevant claiming deadline has not claimed, submitted all required documentation, and been confirmed and validated as eligible, then an alternate winner may be selected. A decision to replace a winner with an alternate is within the sole discretion and judgment of the Maryland Lottery. Once the decision to proceed with an alternate is made, the person who was previously selected as a winner is no longer entitled to a prize.
- 4) If you win a prize and you owe State Obligations, which include but are not limited to child support and/or certain other obligations to a State agency or other governmental entity, then you must pay those outstanding State Obligations in order for the prize to be awarded to you. If any of those outstanding State Obligations are not paid off within five (5) days of claiming the prize, then you will be disgualified and an alternate winner may be selected.

### **OTHER OFFICIAL RULES:**

If any discrepancy exists between these Rules and any other material describing the Promotion or anything related thereto, these Rules shall prevail.

All aspects of this Promotion are governed by these Drawing Rules ("Rules").
