



**Maryland Lottery®**  
**Cash4Life® Best Day Ever 2nd Chance Promotion**  
**Drawing Rules**

**OVERVIEW:**

The Maryland State Lottery and Gaming Control Agency ("Lottery" or "Maryland Lottery") is giving away \$1,000 for every day in July. Beginning any time on June 26, 2017, until 11:59:59 PM on July 26, 2017 ("Promotion Period"), players can participate in the Maryland Lottery® Cash4Life® Best Day Ever 2<sup>nd</sup> Chance Promotion ("Promotion") for a chance to be selected as one of thirty-one (31) \$1,000 winners.

To participate, enter at [mdlottery.com/rewards](http://mdlottery.com/rewards) the information from one (1) winning or non-winning Maryland Lottery Cash4Life Lottery terminal ticket ("Ticket"; plural "Tickets"). Tickets must be purchased and entered during the Promotion Period to be eligible for entry into the Promotion.

Entries are cumulative. Once an entry is submitted, it will remain in the pool of entries unless selected as a winning entry. Entries must be entered by 11:59:59 PM Eastern Time on the Drawing Entry Deadline date of a particular drawing to be included in that drawing. (In these Drawing Rules ("Rules"), all times are Eastern Time.) A total of five (5) drawings will be conducted to select the thirty-one (31) winners. See the chart below for entry deadlines and drawing dates. A drawing may include any random selection event. These are bonus drawings with bonus prizes.

Internet access and a valid email address are required to enter this Promotion and its drawings. Mailed entries will not be accepted. You may enter as often as you like; however, you may only win once. One Ticket equals one entry into the Promotion. YOU DO NOT NEED TO KEEP YOUR ORIGINAL TICKET IN ORDER TO CLAIM YOUR PRIZE IF YOU WIN. (Players and winners are sometimes referred to as "you" and "your".) A Ticket may only be used to enter one time.

**Prize:**

**CLAIMING:**

You will be advised, at the time of notification, of claiming procedures and reminded of the claiming deadlines. Winners and alternates must claim by 4:30 PM on the claiming deadline listed in the chart above. If more than one name is provided on any winning entry, the Lottery will choose which is the winner.

- 1) You may claim your prize as follows. Allow a minimum of 15 business days after the Lottery receives a claim and proof of eligibility for delivery of the prize.
  - a. In person at the Lottery's Baltimore Customer Resource Center, Montgomery Park Business Center, 1800 Washington Blvd., Suite 330, Baltimore, MD 21230;
  - b. Through the mail at the address provided above; or
  - c. Through email or facsimile transmission. An email address and/or fax number will be provided to winners upon request.
- 2) Prizes claimed in person or through the mail, email or through facsimile transmission will be mailed once winner's eligibility has been fully validated. If a winner has been disqualified, or by the relevant claiming deadline has not claimed, submitted all required documentation, and been confirmed and validated as eligible, then an alternate winner may be selected. A decision to replace a winner with an alternate is within the sole discretion and judgment of the Maryland Lottery. Once the decision to proceed with an alternate is made, the person who was previously selected as a winner is no longer entitled to a prize.
- 3) If you win a prize and you owe State Obligations, which include but are not limited to child support and/or certain other obligations to a State agency or other governmental entity, then you must pay those outstanding State Obligations in order for the prize to be awarded to you. If any of those outstanding State Obligations are not paid off within five (5) days of claiming the prize, then you will be disqualified and an alternate winner may be selected.

**OTHER OFFICIAL RULES:**

If any discrepancy exists between these Rules and any other material describing the Promotion or anything related thereto, these Rules (as amended, if amended) shall prevail.

All aspects of this Promotion are governed by these Rules.
