

\$100,000 State Fair Giveaway Additional Winner Drawing

Drawing Rules

OVERVIEW:

On Saturday, September 2, 2017, the Maryland State Lottery and Gaming Agency ("Maryland Lottery" or "Lottery") is conducting a \$100,000 State Fair Giveaway Additional Winner Drawing ("Drawing") at the Maryland State Fair ("State Fair") to select an additional winner to participate in the \$100,000 State Fair Giveaway Event ("Event") taking place at the State Fair, Carolina Carport's Free Stage, from 6-8 PM on Saturday, September 2, 2017. The additional winner will join thirty (30) preliminary drawing winners already selected to attend the Event through the My Lottery Rewards Points for Drawings \$100,000 State Fair Giveaway drawing. At the Event, the additional winner selected in the Drawing will have the chance to be selected to play a variety of games for a cash prize. The additional winner will win at least a \$500 prize just for participating in the Event.

HOW TO ENTER:

Players can enter the Drawing at the Lottery booth in the lobby of the Exhibition Hall at the State Fair from 10 am to 3 pm on September 2, 2017.

To enter the Drawing:

- You must be 18 years of age or older (Players and winners are sometimes referred to as "you" and/or "your"; players may also be referred to as "player", and/or "players".);
- Purchase any combination of \$20 worth of Ravens scratch-off tickets, Game #328, Game #329, and Yahtzee scratch-off tickets, Game #348
 ("Tickets"), at the State Fair (any Maryland Lottery scratch-off tickets other than those listed in these Rules will not be valid tickets for this
 Drawing and will not be eligible or considered);
- Present the Tickets at the Lottery booth in the designated area with the Drawing device;
- The Lottery Representative at the booth will stamp the back of your Tickets, return your Tickets to you, and give you and entry form to complete;
- On the entry form, you will be required to provide your name, hometown, and cell phone number; **if you do not have a phone number, ask a Lottery representative at the Event to assist you on how to proceed;**
- Drop the completed entry form ("Entry" or "Entries") into the Drawing device.
- The Drawing will be held at the Lottery booth at approximately 3 pm.

You may enter as often as you wish; however, you must be present to win and be able to participate in the Event that same day, from 6 pm to 8 pm. Check in for the Event is 4:30 pm. Each Entry will be considered as one entry into the Drawing. Entries should list one name only, or the Lottery will choose which name is the winner. If you have already been selected as a winner in the My Lottery Rewards™ Points for Drawings \$100,000 State Fair Giveaway drawing, you are not eligible to participate or to win in the Drawing at the State Fair.

Entries must be in the Drawing device at the time the Drawing takes place at the Event to be eligible for the Drawing. Entries will be accepted up until the Drawing. You must be present to win.

All aspects of this Drawing are governed by these Drawing Rules ("Rules") and any amendments thereto. This is a bonus game and these are bonus prizes.

The Lottery reserves the right to reschedule any times and dates regarding this Drawing, including the dates and times of the Event and time of the Drawing, if necessary, without advance notice. Should the volume or number of Entries for the Drawing at this Event exceed the working capacity of the Drawing device, as determined by the Lottery, the Lottery reserves the right to conduct one or more random pre-drawing(s) to determine the final Entries for that Drawing. A "drawing" may include any random selection event.

CLAIMING:

The winner's name will be announced and posted immediately following the Drawing. If the winner is not present at the Lottery booth when selected, a Lottery representative will call the winner, and the winner will have 15 minutes to claim their prize. If the announced winner does not claim or cannot be confirmed or preliminarily validated within 15 minutes after the Drawing, the Lottery may select an alternate winner. Each alternate winner will have 15 minutes to claim their prize or the Lottery may select another alternate winner. A decision to replace a winner with an alternate winner is within the sole discretion and judgment of the Maryland Lottery. Once the decision to proceed with an alternate winner is made, the person who was previously selected as a winner is no longer entitled to a prize or compensation of any kind.

The winner must sign a waiver and complete a Lottery Claim Form, including Social Security number ("SSN"), and must provide proof of their SSN and must furnish photo I.D. proof of being at least 18 years of age. Final determination regarding confirmation of winning and of qualification and eligibility to win will be made after presentation and review of all relevant documentation and information. To preliminarily claim at the Event, each winner must complete a Maryland Lottery Claim form and show photo I.D. proof of being at least 18 years of age.

If the preliminarily-validated winner or alternate of the Drawing prize is unable to provide all the required documentation at the Event to complete the claiming process, that winner, or alternate if applicable, will have 30 days after the date of that Event to provide the required documentation and must do so by 4:30 pm on the relevant day, either in person or through the mail (received by the relevant day and time) to the Maryland Lottery Customer Resource Center, 1800 Washington Boulevard, Suite 330, Baltimore, MD 21230.

Please allow a minimum of 15 business days after the Lottery receives a claim for delivery of any prize.

You do not have the option to request or receive a substitute or equivalent prize, including cash, for any prize. In the event that the Event is cancelled or rescheduled, the Lottery shall not be subject to any liability.

If you owe child support or certain other debts to a State agency or other governmental entity, any amount that would have been awarded as a cash prize will be applied to your unpaid child support and/or to certain other debts owed to a State agency or other governmental entity. Further amounts may be owed. Winners are responsible for all tax liabilities, including income taxes.

In the event of winner's death or inability to partake of a prize, the Lottery will make a determination about the awarding of the prize.

OTHER OFFICIAL GAME RULES:

By entering this Drawing, winner agrees: 1) to participate in any related Lottery event, including any Lottery event that may be public, taped, or televised, or to send a proxy who will participate, and that the Lottery reserves the right to approve or reject any proxy designated by a winner; 2) for yourself and any proxy, that during any public, taped, or televised Lottery event they will behave in a reasonable, respectful and cooperative manner and will not be under the influence of drugs or alcohol, 3) to wear, at any public, taped, or televised Lottery event, clothing that contains no logos or writing, and the Lottery reserves the right to determine what clothing is acceptable for appearing in the public, taped, or televised Lottery event; and 4) that the Lottery also reserves the right to: require the

winners to wear clothing provided by the Lottery; and appoint a proxy or stand-in if the winner's or proxy's clothing, behavior, or other aspect is not acceptable, in the Lottery's reasonable sole discretion.

By submitting an Entry for or participating in any way in this Drawing, you and any users of any prize acknowledge, understand, consent and agree to the following:

- a) to unconditionally release, hold harmless, indemnify, and defend the Maryland Lottery, the Maryland State Lottery and Gaming Control Commission ("Commission") the State of Maryland, and their members, agents, employees, officials, representatives, successors and assigns (individually and collectively also referred to herein as "Indemnified Parties") from any liability arising out of participation in this Drawing, or any related event or occurrence, and/or out of the awarding, receipt, possession, use, misuse, and/or acceptance of a prize, from any breach of any obligation(s) by any third party(s), and/or from any injury, death, or damage resulting from participation in this Drawing, and/or its prizes and/or use of its prizes, even if caused by Indemnified Parties or any other person, whether through negligence or any other cause;

- c) to sign any waivers and releases of liability required by the Lottery, and to sign news and press release forms; and to ensure that any of your guests also sign waivers and releases of liability;
- d) to participate in a check/prize presentation ceremony as determined by the Lottery;
- to publicity and to have your, Lottery players', winners', guests', participants', and users' name, photos, hometown and/or state aired on TV, radio, text messages, the Internet including the Lottery's website, social media such as Facebook, Twitter, Instagram and YouTube, and other media, and in other publicity, as well as used in Lottery publications and advertisements, Lottery mailings, and/or other Lottery-related activities, including mailing lists, all at the discretion of the Director;
- f) that Indemnified Parties are not responsible for any negligence of any person, or for any claim, liability, injury, death, property loss, or other damage of or to Lottery players, winners, and other participants, and/or their family members, or other persons, arising directly or indirectly from or in connection with the participation in or the use or misuse of prizes awarded, or with participation in this Drawing or in any event or occurrence related to this Drawing, including, but not limited to claims for damage to property, for personal injury or death, or claims based on defamation, rights of privacy, rights of publicity, or delivery of cash or merchandise, or other prize, even if it is caused by the negligence of Indemnified Parties or any other person:

- i) that the Lottery reserves the right in its sole discretion a) to substitute for any prize a prize of approximately equivalent value, or higher, as determined by the Lottery, including a cash equivalent; b) to cancel or reschedule any times and/or dates, including any Drawing, and/or c) to cancel or reschedule fulfillment of any prize;
- j) that an entrant, winner, or guests may not request a substitute or equivalent prize; and that actual prizes may vary;
- k) that the Lottery does not endorse any company or other entity by offering a game, promotion or prize from or related to that company or other entity or by holding any event at any entity's location:

 - 3. any participant in the Lottery's Voluntary Exclusion Program;
- q) If any discrepancy exists between these Rules and any other material describing the Drawing or anything related thereto, these Rules shall govern;
- by participating in or entering this Drawing, you agree to be bound by these Rules, in addition to any applicable laws and regulations including the Maryland Lottery law and related regulations; the Lottery will make all determinations concerning the validity of entries, winners, and other decisions required for this Drawing; all decisions of the Lottery shall be final; the Lottery reserves the right to modify, amend, or change without notice any rule(s) and any time(s) and date(s); for further information about this Drawing, and important dates, visit the Lottery's website at mdlottery.com;
- the following are **not valid entries and will not be considered** or entered in this Drawing: any incomplete or illegible entry; any entry that is prohibited, disqualified, or does not comply with these Rules; any entry received after any deadline; and any entry received in any manner other than as stated in the Rules; and
