



Sheetz[®] Free Subz for a Year

Second Chance Promotion

Drawing Rules

OVERVIEW:

Beginning any time on August 23, 2017 until 11:59:59 PM Eastern Time (“ET”) on September 30, 2017 (“Promotion Period”), players can participate in the Maryland State Lottery and Gaming Control Agency (“Lottery” or “Maryland Lottery”) Sheetz[®] Free Subz for a Year Second Chance Promotion (“Promotion”) for a chance to win free subs at Sheetz, Inc. (“Sheetz”). Prizes will be awarded in the form of Sheetz Loyalty Cards (“Cards”, or “Card”). Five (5) drawings will be held throughout the Promotion Period to select a total of twenty-one (21) winners. Twenty (20) winners will be selected to win a Card for free subs for an estimated usage of one (1) month (i.e., 30 subs) valued at \$150 each (“Free Subz for a Month”), and one (1) winner will be selected to win a Card for free subs for an estimated usage of one (1) year (i.e., 365 subs) valued at \$1,825 (“Free Subz for a Year”). A total value of \$4,825 will be given away in Cards during the Promotion. See below for drawing entry deadlines, drawing dates, number of winners, prizes and prize values, and claiming deadlines.

PRIZE:

Each Card will be loaded with sub credits* for the prize amount won, and can only be used towards the purchase of Sheetz 6” MTO[®] (Made To Order) subs. The quantity of sub credits won for each respective prize will be either 1) loaded onto a winner’s existing Card, or 2) if the winner does not have an existing Card, then loaded onto a new Card that will be delivered to the winner. The value of Cards for Free Subz for a Month and Free Subz for a Year are based on estimated usage for those time periods, which is the equivalent of one sub per day for the respective time period. Cards are valid for at least one year from the date winner receives the sub credits. (*Sub credits have no cash value.)

HOW TO ENTER:

To participate, enter at mdlottery.com/sheetz one winning or non-winning Maryland Lottery[®] Mega Millions[®] ticket in the amount of \$10 or more on a single ticket purchased from any participating Sheetz location in Maryland during the Promotion Period (“Ticket” or “Tickets”). Each \$10 Ticket entered equals one (1) entry into the drawing. (A \$10 Ticket equals one (1) entry into the drawing, a \$20 Ticket equals two (2) entries into the drawing, a \$30 Ticket equals three (3) entries into the drawing, etc.) Throughout the Promotion, twenty (20) winners will be drawn to win Free Subz for a Month, and one (1) winner will be drawn to win Free Subz for a Year.

Entries are cumulative. Once an entry is submitted, it will remain in the pool of entries unless selected as a winning entry. For each drawing: Entries must be entered for a specific drawing by 11:59:59 PM ET on the announced Drawing Entry Deadline date (see above) to be eligible for that drawing. [In these Sheetz[®] Free Subz for a Year Second Chance Promotion Drawing Rules (“Rules”), all times are Eastern Time.] A drawing may include any random selection event. These are bonus drawings with bonus prizes.

Internet access and a valid email address are required to enter this Promotion and its drawings. Mailed entries will not be accepted. You may enter as often as you like; however, you may only win once throughout the Promotion. Only Tickets purchased and entered during the Promotion Period are valid entries. For second-chance Drawings, you do not need to keep your original Ticket(s) in order to claim your prize if you win. (Players and winners are sometimes referred to as “you” and “your”.) A Ticket may only be used to enter one (1) time.

Winner will receive a W-2G from the Lottery for any prize over \$600.

Winners will be announced at mdlottery.com/rewards and may be announced elsewhere as well.

CLAIMING:

You will be advised, at the time of notification, of claiming procedures and reminded of the claiming deadlines. Winners and, if applicable, alternates for each drawing must claim your prize by 4:30 PM on the applicable claiming deadline listed in the chart above. If more than one (1) name is provided on any winning entry, the Lottery will choose which is the winner.

Winners may claim your prize as follows.

For the winner of the Free Subz for a Year prize:

You must claim your prize in person by 4:30 PM of the claiming deadline date listed in the chart above at the Lottery's Baltimore Customer Resource Center, Montgomery Park Business Center, 1800 Washington Boulevard, Suite 330, Baltimore, MD 21230.

For winners of the Free Subz for a Month prize:

- 1) You may claim your prize:
 - a. Through the mail at the Lottery's Baltimore Customer Resource Center at the address provided above; or
 - b. In person at the Lottery's Baltimore Customer Resource Center at the address provided above; or
 - c. Through email or facsimile transmission. An email address and/or fax number will be provided to winners upon request.
- 2) Prizes claimed through the mail, email or through facsimile transmission will be mailed within the period stated above once winner's eligibility has been fully validated. If a winner has been disqualified, or by the relevant claiming deadline has not claimed, submitted all required documentation, and been confirmed and validated as eligible, then an alternate winner may be selected. A decision to replace a winner with an alternate winner is within the sole discretion and judgment of the Maryland Lottery. Once the decision to proceed with an alternate winner is made, the person who was previously selected as a winner is no longer entitled to a prize or compensation of any kind.

For all winners:

- 1) Winner must furnish photo I.D. proof of being at least eighteen (18) years of age. All winners are responsible for all taxes, including income taxes.
- 2) If you win a prize and you owe State Obligations, which include but are not limited to child support and/or certain other obligations to a State agency or other governmental entity, then you must pay those outstanding State Obligations in order for the prize to be awarded to you. If any of those outstanding State Obligations are not paid off within five (5) business days of claiming the prize, then you will be disqualified, and an alternate winner may be selected.
- 3) In the event of a winner's death or inability to partake of a prize, the Lottery will make a determination about the awarding of the prize. The Lottery's decision will be final.
- 4) You do not have the option to request or receive a substitute or equivalent prize, including cash, for any prize.

Once winner's eligibility has been fully validated, i.e., after the Lottery receives a fully completed claim form and proof of eligibility and any other necessary documentation, each winner's name, address, phone number and email address will be provided to Sheetz. Please allow a minimum of thirty (30) consecutive days from the time Sheetz receives each winner's information for delivery of any prize.

OTHER OFFICIAL RULES:

If any discrepancy should exist between these Rules and any other material describing this Promotion or anything related thereto, these Rules shall prevail.

All aspects of this Promotion are governed by these Rules and any amendments thereto.

Neither the Lottery nor Sheetz are responsible for any lost, late, misdirected, undeliverable or incomplete entry, whether due to any system error or failure, faulty transmission or other telecommunication malfunction, any entry not received resulting from any hardware or software failure of any kind, any lost or unavailable network connection, any failed, incomplete or garbled computer or telephone transmission, any typographical or system error and/or failure, any technical malfunction or otherwise.

You agree that any and all disputes, claims, and causes of action arising out of, or connected with, the Promotion or any prize awarded shall be resolved individually, without resort to any form of class action.
