## Maryland Lottery® My Lottery Rewards™ Cash4Life® Best Day Ever 2<sup>nd</sup> Chance Promotion Drawing Rules

### **OVERVIEW:**

Beginning any time on Monday, August 3, 2020, until 11:59:59 PM Eastern Time on Sunday, August 30, 2020 ("Promotional Period"), players can enter the Maryland Lottery® My Lottery Rewards™ Cash4Life® Best Day Ever 2<sup>nd</sup> Chance Promotion ("Promotion") offered by the Maryland State Lottery and Gaming Control Agency ("Lottery" or "Maryland Lottery") for a chance to win a cash prize of \$1,000 a day for thirty (30) days (\$30,000) or \$100 a day for thirty (30) days (\$3,000). The Lottery will conduct one 2<sup>nd</sup> Chance Drawing ("Drawing") to select a total of twenty-five (25) winners to win an estimated total of \$102,000 in prizes. One (1) winner will win \$30,000 and twenty-four (24) winners will win \$3,000. See below for more information.

### **HOW TO PARTICIPATE:**

To participate, enter through My Lottery Rewards ("MLR") at [mdlottery.com/rewards](http://mdlottery.com/rewards), or through the MLR App any combination of winning or non-winning Maryland Lottery® Cash4Life Lottery terminal tickets equal to seven (7) Cash4Life games (a total of \$14.00 worth of Cash4Life tickets) and/or any other game tickets specified by the Lottery (collectively, "Tickets"; singular "Ticket") to receive 25 entries into the Drawing. One (1) game equals one (1) \$2 purchase. A qualifying entry into the Promotion is seven (7) Cash4Life games purchased and entered during the Promotional Period. You do not need to keep your original Tickets in order to claim your prize if you win. A Ticket may only be used to enter one time.

Entries must be entered by 11:59:59 PM Eastern Time on the given announced Drawing Entry Deadline date to be eligible for that Drawing. (In these Rules, all times are Eastern Time.) **See the Drawing Chart below for Start Date, Drawing Entry Deadline, Drawing Date, # of Winners, Prizes, and Claiming Deadlines.**

A drawing may include any random selection event. This is a bonus Drawing with bonus prizes.

Internet access and a valid email address are required for you to enter this Promotion and its Drawing. (Players and winners are sometimes referred to as "you" and "your".) Mailed entries will not be accepted. You may enter as often as you like; however, you may only win once.

To enter, you must be 18 years of age or older. All winners must be at least 18 years of age.

**All winners, including alternate winners ("Alternates"), must claim your prize by 4:30 PM on the respective Claiming Deadline dates shown above.**

### **PRIZE DESCRIPTION:**

#### **\$1,000 a day for 30 days (\$30,000):**

One (1) winners will be selected to each receive a cash prize of \$30,000 in the form of a check.

**\$100 a day for 30 days (\$3,000):**

Twenty-four (24) winners will be selected to each receive a cash prize of \$3,000 in the form of a check.

**CLAIMING:**

You will be advised, at the time of notification, of claiming procedures and reminded of Claiming Deadlines. Claiming Deadlines for winners and Alternates are included in the chart above. All winners must claim your prize **by 4:30 PM of the Claiming Deadline date** listed in the chart above.

If a winner is disqualified or by the relevant Claiming Deadline has not claimed, submitted all required documentation, and been confirmed and validated as eligible, then an Alternate may be selected. A decision to replace a winner with an Alternate is within the sole discretion and judgment of the Maryland Lottery. Once the decision to proceed with an Alternate is made, the person who was previously selected as a winner is no longer entitled to the prize. Alternates must claim by 4:30 PM on the Claiming Deadline date designated for that Alternate.

Winners must claim your prize in person at the Lottery's Baltimore Customer Resource Center, Montgomery Park Business Center, 1800 Washington Boulevard, Suite 330, Baltimore, MD 21230.

- 1) Winners must present proof of your social security number and must furnish photo I.D. proof of being at least 18 years of age.
- 2) If you have any unpaid State Obligations, the cash prize will be applied first to your unpaid State Obligations. You will be taxed on the value of the cash prize. Further amounts may be owed.
- 3) In the event of a winner's death or inability to partake of a prize, the Lottery will make a determination about the awarding of the prize. The Lottery's decision will be final.
- 4) You do not have the option to request or receive a substitute or equivalent prize for any prize.

You do not need to keep your original ticket in order to claim your prize if you win. (Players and winners are sometimes referred to as "you" and "your".) A qualifying entry is one (1) Ticket. A Ticket may only be used to enter one time. The number of entries per Ticket is equal to the price of the Ticket.

Winners will each receive a W-2G form from the Maryland Lottery. You will be taxed on the amount(s) won. All winners are responsible for all taxes, including income taxes.
