



Maryland Lottery® My Lottery Rewards™ Holiday Cash & Dash 2020 2nd Chance Promotion Drawing Rules

OVERVIEW:

Beginning any time on Monday, October 19, 2020, until 11:59:59 PM on Monday, January 11, 2021, players can enter the Maryland Lottery® My Lottery Rewards™ Holiday Cash & Dash 2020 2nd Chance Promotion (“Promotion”) offered by the Maryland State Lottery and Gaming Control Agency (“Lottery” or “Maryland Lottery”) for a chance to win a Warehouse Dash® in Chicago (“Warehouse Dash”), travel, cash, and/or merchandise prizes. Scientific Games International, Inc. on behalf of itself and its wholly-owned subsidiary MDI Entertainment, LLC (collectively, “SGI”) will completely fulfill the Warehouse Dash prize.

HOW TO PARTICIPATE:

To participate, enter at mdlottery.com/holiday, through the MLR at mdlottery.com/rewards, or through the MLR App non-winning Maryland Lottery® 2020 holiday scratch-off tickets (#505 Holiday Lucky - \$1, #506 Holiday Luck X2 - \$2, #507 Peppermint Payout X3 - \$3, #508 Holiday Luck X5 - \$5, #509 Holiday/Winter Luck X10 - \$10 (this ticket has two designs)), and/or any other ticket specified by the Lottery (collectively, “Tickets”; singular “Ticket”). The number of entries received for a submitted Ticket equals the price of the Ticket, i.e., \$1 Ticket equals one (1) entry; \$2 Ticket equals two (2) entries, etc.

Prizes: There will be a series of twelve (12) 2nd Chance Drawings (“Drawings”; singular “Drawing”) throughout the Promotion. Prizes include a total of four (4) Warehouse Dash prizes, one (1) \$25,000 cash prize, one (1) \$25,000 cash prize, five (5) \$10,000 cash prizes, twenty-seven (27) \$5,000 cash prizes, twenty-one (21) \$2,500 cash prizes, one hundred eighty (180) \$1,000 cash prizes, and one hundred (100) merchandise prizes which include a choice of an Apple® iPad®, Apple® iPad mini®, Apple Watch®, HDTV, or a Dyson® Vacuum. A total of 338 winners will be selected to win an estimated total of \$609,066 in experiential prizes, cash, and merchandise prizes.

For each Drawing: Entries must be entered for a specific Drawing by 11:59:59 PM Eastern Time on the announced drawing entry deadline date to be eligible for that Drawing. (In these Rules, all times are Eastern Time.) Entries are cumulative. Once an entry is submitted, it will remain in the pool of entries unless selected as a winning entry. **See the Drawing Chart below for Drawing Number, Drawing Entry Deadlines, Drawing Dates, Number of Winners, Prizes, and Claiming Deadlines.** These are bonus Drawings, and the Dash plus \$500 cash prize, \$25,000, \$10,000, \$5,000, \$2,500, and \$1,000 cash prizes, and merchandise prizes are bonus prizes.

Internet access and a valid email address are required to enter this Promotion and its Drawings. Mailed entries will not be accepted. Winners in each Drawing will be drawn starting with the highest prize value first, followed by the next highest, etc. The Warehouse Dash prize is the highest prize. You may enter as often as you like; however, you or one member per residence address may only win:

- Once per Drawing, the highest prize for which you were selected;
- One (1) Warehouse Dash prize in the Promotion; and
- Once per residence address; only one winner per each residence address is allowed per drawing;

You do not need to keep your original ticket in order to claim your prize if you win. (Players and winners are sometimes referred to as “you” and “your”.) A qualifying entry is one (1) Ticket. A Ticket may only be used to enter one time.

To enter, you must be 18 years of age or older. All winners must be at least 18 years of age.

Dasher's Dash Interactive Game:

- Players entering Tickets into My Lottery Rewards ("MLR") will be prompted to play the interactive "Dasher's Dash" game ("Game"), a Skill-With-Reveal hidden object game that takes players to a holiday village with a dozen game play locations.
- You are not required to play the Game when entering your Tickets. You may choose the "Opt Out" feature of the Game.
- You will still receive progress towards MLR achievements and the second-chance entries associated with each Ticket entered, even if you opt out of the Game.
- If you choose to play the Game, you are given 60 seconds to find 6 (six) hidden objects.
- Finding objects quickly awards bonus points within the Game, and new locations can be unlocked by entering additional Tickets.
- You can continue to play previously unlocked locations for fun.
- You can log into your social media account to share your scores.
- After each Game, you can compare your score with other players by viewing the daily and all-time leaderboards.

PRIZE DESCRIPTIONS:**Warehouse Dash® prize**

Four (4) winners will be selected in the 12th and final Drawing of the Promotion to win a Warehouse Dash, travel to Chicago, Illinois to the Warehouse Dash, and \$500. Each Warehouse Dash prize will include a three (3) day, two (2) night trip for two (winner and one guest; guest must be 18 years of age or older) to Chicago, Illinois; roundtrip coach airfare for up to two (2) people from any U.S. International airport to Chicago, Illinois (inclusive of all associated security fees, taxes and surcharges) or travel allowance up to \$1,200 toward another mode of transportation to travel to Chicago to the hotel; all ground transfers between the destination airport, hotel and SGI--sponsored events; deluxe hotel room for two (2) nights (double occupancy, room and room tax only) at a three diamond rated hotel or better; and \$500 spending money for the winner to be provided in the form of a check approximately two (2) weeks prior to the scheduled trip departure date. (Winner and guest may travel from different airports; however, travel from different airports involves restrictions regarding flights and ground transfer.) Winners and guests will be honored with a welcome reception/dinner the evening of their arrival in Chicago.

The Warehouse Dash prize will also include admission for winner and guest to the Maryland Lottery Dash Event ("Dash" or "Dash Event") located at the Hinda, Inc. ("Hinda") warehouse, where the winner and guest will have an opportunity to participate in a ninety second (:90) dash through the Hinda warehouse. Both the winner and guest participate in the Dash; one person is designated to push the cart and the other person who will fill the cart by successfully placing as much merchandise into the winner's shopping cart. Winner is solely responsible for the actions of the guest who accompanies the winner to the Dash and other events. Estimated prize value: \$27,789 each including tax withholdings.

\$25,000 Cash:

One (1) winner will receive a cash prize of \$25,000.

\$10,000 Cash:

Five (5) winners will each receive a cash prize of \$10,000.

\$5,000 Cash:

Twenty-Seven (27) winners will each receive a cash prize of \$5,000.

\$2,500 Cash:

Twenty-one (21) winners will each receive a cash prize of \$2,500.

\$1,000 Cash:

One Hundred Eighty (180) winners will each receive a cash prize of \$1,000.

Merchandise:

One Hundred (100) winners will each receive a choice of **one** of five (5) merchandise prizes. Each winner of a merchandise prize will be able to choose one prize from a selection of five (5) different items: Apple® iPad® (Estimated prize value: \$572.76), Apple® iPad mini® (Estimated prize value: \$562.76), Apple Watch® (Estimated prize value: \$542.76), LG 50" HDTV (Estimated prize value: \$525.41), or a Dyson® Vacuum (Estimated prize value: 566.85).

***SGI will completely fulfill the 100 merchandise prizes. Winners of merchandise prizes will be notified by SGI using the email address provided in the winner's MLR account.**

All winners, including alternate winners ("Alternates" or "Alternate"), must claim your prize by 4:30 PM on the respective claiming deadlines shown above.

CLAIMING:

You will be advised, at the time of notification, of claiming procedures and reminded of claiming deadlines. Claiming deadlines for winners, including Alternates, are included in the chart above.

- Winners of the Warehouse Dash, \$25,000, \$10,000, \$5,000, and \$2,500 prizes must claim your prize in person **by 4:30 PM of the claiming deadline date** at the Maryland Lottery Baltimore Customer Resource Center, Montgomery Park Business Center, 1800 Washington Boulevard, Suite 330, Baltimore, MD 21230.
- Winners of the \$1,000 prizes may claim your prize in person at, or by mail (with a Lottery Claim form and required documentation enclosed) to, the address in the preceding sentence, or through email or facsimile transmission (with a Lottery Claim form and required documentation enclosed). An email address and/or fax number will be provided upon request. Winners must allow a minimum of 15 business days after the Lottery receives a claim for delivery of your prize.
- If a winner has been disqualified, or by the relevant claiming deadline has not claimed, submitted all required documentation and information, including completing waivers for both the winner and the guest, and been confirmed and validated as eligible, then an Alternate winner may be selected. Alternates must claim by 4:30 PM of the claiming deadline designated for Alternates.
- Winners of the Warehouse Dash must claim your prize in person at the Lottery's Baltimore Customer Resource Center, Montgomery Park Business Center, 1800 Washington Boulevard, Suite 330, Baltimore, MD 21230.
 - Winners must furnish photo I.D. proof of being at least 18 years of age.
- In the event of a winner's death or inability to partake of the Warehouse Dash, the Lottery will make a determination about the awarding of the Warehouse Dash. The Lottery's decision will be final.
- **In Case of Emergency.** Winners or alternates whose claim deadlines occur during a state of emergency will be able to claim their prize for up to 30 days after the state of emergency has been lifted (or another period of time, if a different period of time is provided regarding that state of emergency). The processing of checks during a state of emergency may take up to 30 days.
- Winners of prizes valued at over \$1,000 and winners of experiential prizes (including travel prizes like the Warehouse Dash), who must normally claim their prize in person at Maryland Lottery Headquarters (same address as stated above), may be allowed to claim by mail or email during a state of emergency with documentation as required by the Lottery for that type of prize and for that Drawing.
- You do not have the option to request or receive a substitute or equivalent prize for any prize.

Scientific Games International, Inc. on behalf of itself and its wholly-owned subsidiary MDI Entertainment, LLC (collectively, "SGI") will completely fulfill the Warehouse Dash prize, including all items won during the Dash Event. SGI will pay the estimated State and Federal tax withholdings for the Warehouse Dash prize, including all items won during the Dash Event, and will send you a W-2G form for this prize. The Maryland Lottery will send you a W-2G form for the \$25,000, \$10,000, \$5,000, \$2,500, and \$1,000 prizes. All amounts paid to you or on your behalf will be included in your reportable income. You will be taxed on those amounts. All winners are responsible for all taxes, including income taxes.

All items won during the Dash Event will be inventoried by Hinda and then shipped by Hinda within twenty (20) business days after the Dash Event to the respective address of the winner as listed in the Prizewinner's My Lottery Rewards registration. In the event that any items won during the Dash Event are damaged or defective upon receipt by the winner, the winner must notify Hinda within thirty (30) calendar days from the winner's receipt of the Dash items won in order for the damaged or defective items to be replaced by Hinda at no cost to the winner.

ADDITIONAL WAREHOUSE DASH RULES:

If the winner is traveling via air and fails to appear at the designated time and place of departure and/or if any winner fails to check into the hotel after arriving in Chicago, the winner forfeits the balance of the Warehouse Dash prize with the exception of the \$500 cash portion, less any tax withholdings; unless Prizewinner makes his or her own replacement travel and/or lodging arrangements at Prizewinner's expense. If the winner fails to arrive for the scheduled participation in the Dash Event, the winner forfeits the right to personally participate in the Dash Event. However, in any of those situations, two (2) proxies will be appointed to play the Dash for the winner and guest, and the winner shall receive any prizes won by the proxies.

In the event a winner is unable to attend the Dash Event due to unforeseen and reasonable circumstances, the balance of the Warehouse Dash prize shall be forfeited with the exception of the \$500 cash portion less any tax withholdings; however, two (2) proxies will be appointed to play the Dash for the winner and guest, and the winner will receive any prizes won by the proxies.

If a winner has a physical limitation that may prevent the winner from participating in the Dash Event but still intends to attend and does attend the Warehouse Dash prize, the winner must travel with a companion who is capable of participating in the Dash Event. If required, one (1) proxy will be appointed to assist the winner's guest during the Dash.
