ACTIVATION REMINDER

DO NOT sell scratch-offs that are not activated! This often happens when store employees mistakenly load inactive books into vending equipment or dispensers. Doing so violates Lottery policies and upsets players.

Be sure to separate inactive books to avoid confusion. Remember, you are financially responsible for issues that occur if your store sells an inactive scratch-off. Thanks for your help!

YOU ASK — WE ANSWER



Q: What is the VEND button on the terminal and why is it there?

A: The VEND button appears on the terminal for retailers that have a self-service Lottery vending machine. Use the button to view vending machine reports from your terminal without having to go to the self-service unit.

COMING SOON:

DEBIT CARD PAYMENTS AT VENDING EQUIPMENT

■ OOD NEWS, RETAILERS! We are adding debit cards as a payment option for players who use our PlayCentral HD, PHDL and PEX vending equipment.

In late January and February, we will start activating debit-card readers that came with new vending equipment which was installed in recent months. We will alert stores that have this equipment when debit-card purchases can begin.

The Maryland Lottery has about 1,400 PHDs and 200 PEX machines in the field but few are equipped with debit-card readers. From February-May, Scientific Games staff members will schedule visits to retailers to retrofit the older equipment with debit-card readers and new software.

We will post frequently asked questions about our debit card initiative on Retailer Corner in January. You can also watch future Retailer Review videos on Retailer Corner for information.

EQUIPMENT TROUBLE? CHECK YOUR TERMINAL!

IT'S EASY to find the phone number to report equipment issues. Look on your terminal for the red sticker that says SCIENTIFIC GAMES HOTLINE. You can call for help 24 hours a day, seven days a week at 1-888-427-7568.

When you call, choose option 1 and have your eight-digit retailer identification number ready to give to the Scientific Games employee. As indicated in the Maryland Lottery and Gaming Fiscal Year 2020 Customer Service Annual Report, the Scientific Games call center does a great job getting you back up and running.

In Fiscal Year 2020 (July 1, 2019-June 30, 2020), this center received about 30,500 calls from Maryland retailers. On average, the call center answered 99% of retailer calls in less than 10 seconds. The call center solved the issue, on average, in about four minutes. Approximately 60% of problems are resolved over the phone. That's great news!

Remember to call the Scientific Games hotline number. If you call the Lottery office after hours or on the weekend, your call will not be answered until the next business day. Call 1-888-427-7568 for help!

Show them how to find the responsible gaming tab on Lottery terminals. Pushing that tab will print out the 1-800-GAMBLER information along with the receipt for a player's Lottery purchase. This is a great way to discreetly give information to players you

suspect may have problem gambling issues.

STOLEN SCRATCH-OFFS?



- F THE WORST HAPPENS, follow these two steps immediately and be sure to use the **NEW** number (shown below) for Lottery Security.
- 1) Call the local police and report the theft. 2) Call either:
 - Lottery Security 410-230-8755 if the theft takes place between 8 a.m.-4:30 p.m. Monday-Friday OR
 - Scientific Games 1-888-427-7568 if the theft takes place after 4:30 p.m. Monday-Friday or anytime on weekends or holidays.

Have your eight-digit retailer identification number ready to share as well as all relevant game numbers, pack numbers and individual ticket numbers of the stolen tickets so we can deactivate the scratch-offs. LOTTERY EXTENDS SCRATCH-OFF SETTLEMENT PERIODS

ARE YOU MANAGING your scratch-off inventory with the new settlement policy in mind? In December, the Maryland Lottery reinstated a policy that extends ticket settlement dates during the State of Maryland's COVID-19 continuing state of emergency.

The policy extends settlement periods from 60 days to 120 days until further notice. This action gives you two more months to sell your activated tickets. The policy applies to all books you activate until the Lottery announces a change in the settlement terms and to all currently activated books in your inventory. This does NOT change the settlement periods for books that settle based on cashing 80% of low-tier prizes.

The Lottery reserves the right to go back to our 60day settlement period once the state of emergency has eased. Watch for updates via email (make sure we have your current email address) and on Retailer Corner.

CASH WINNING TICKETS!



e receive numerous written, phone and social media complaints from players with winning tickets who say a retailer refused to cash their ticket.

We log and investigate these complaints by speaking with the player and then contacting your business (or corporate headquarters) to get your side of the story. Too often, players' complaints are valid.

Remind your managers and store clerks that your business earns a 3% commission on anything cashed through the Lottery terminal. In addition, make sure they know that retailers **MUST** cash winning tickets up to and including \$600 to maintain a Lottery license. All Expanded Cashing Authority Program retailers must cash winning tickets up to and including \$5,000 to maintain XCAP status. Thanks for your help!
