ENTRY DATES: Tuesday, October 5, 2021 at 00:00:00 AM Eastern Time ("ET") – Monday, January 3, 2022 at 11:59:59 PM ET.

DRAWING DATE: Tuesday, January 4, 2022

CLAIMING DEADLINE: February 3, 2022; Alternate March 7, 2022

POINTS REQUIRED FOR ENTRY: 75 Draw Points

WINNERS: 1

ESTIMATED TOTAL PRIZE VALUE: \$16,366.17 (Includes estimated State and Federal tax withholdings)

PRIZE DETAILS:

Key Largo Vacation Trip Prize ("Trip Prize"):

This Trip Prize includes:

- A four (4) day, three (3) night vacation for two adults (winner and guest) to Key Largo;
- Roundtrip coach class airfare for two (winner and guest) on a major airline, as defined by the Federal Aviation Administration, from a U.S. international airport selected by the winner to any major city near Key Largo, Florida;
- Four Star hotel accommodations at the Bungalows Key Largo Hotel for two (winner and guest) for four (4) days/three (3) nights. Winner and guest must be at least 18 to win the Trip Prize, and at least 21 years or older to stay at the Bungalows Key Largo Hotel. If Winner and/or guest is under 21, a different resort will be selected;
- Breakfast daily, parking, portorage, taxes and gratuities;
- Four (4) day car rental; and
- \$1,500 Travel/Entertainment/Meal allowance.

Claiming:

You will be advised, at the time of notification, of claiming procedures and reminded of claiming deadlines.

If a winner has been disqualified, or by the relevant claiming deadline has not claimed, submitted all required documentation and information, including submitting completed associated **waivers for both the winner and the guest**, and been confirmed and validated as eligible, then an Alternate may be selected. A decision to replace a winner with an Alternate is within the sole discretion and judgment of the Maryland Lottery. Once the decision to proceed with an Alternate is made, the person who was previously selected as a winner is no longer entitled to the Trip Prize. Alternates must claim by 4:30 PM on the claiming deadline designated for that Alternate, following the same procedure as outlined below for winner.

The winner must claim the Trip Prize as follows:

- 1) You must claim your Trip Prize in person at the Maryland Lottery's Baltimore Customer Resource Center, Montgomery Park Business Center, 1800 Washington Boulevard, Suite 330, Baltimore, MD 21230.
- 2) Winner and guest must both furnish photo I.D. proof of being at least 21 years of age to stay at the Bungalows Key Largo Hotel, and winner and guest must complete and sign a waiver and release of all liability. If winner and/or guest is under 21, a different resort will be selected; however, winner and guest must still be at least 18. (If guest does not accompany winner to claiming, guest may sign the required Lottery waiver later, but winner must sign at claiming). SGI will provide its waiver for signing as determined by SGI.
- 3) If you win the Trip Prize and you owe State Obligations, which include but are not limited to child support and/or certain other obligations to a State agency or other governmental entity, then:
 - a. If you owe less than \$1,500.00 (the cash portion of the prize) the cash portion of the Trip Prize (\$1,500.00) will be applied first to those State Obligations.
 - b. If you owe more than \$1,500.00, you have options:
 - i. The Lottery will apply the \$1,500.00 of the Trip Prize to your State Obligations and you pay the rest within 5 days; or
 - ii. You can decline the prize and sign a Refusal of Prize and Waiver and Release of all Liability, and an Alternate may be selected; or
 - iii. If you do not pay off all of those outstanding State Obligations within five (5) business days of claiming the Trip Prize, then you will be disqualified and an Alternate may be selected. See MLR Terms of Use (link provided below) for further provisions.
- 4) In the event of a winner's death or inability to partake of the Trip Prize, the Lottery will make a determination about the awarding of the Trip Prize. The Lottery's decision will be final.
- 5) You do not have the option to request or receive a substitute or equivalent prize for any Trip Prize.

Scientific Games International, Inc. or its subcontractor(s) (hereinafter "SGI") will completely fulfill the Trip Prize and pay the required estimated State and Federal tax withholdings. A W-2G or other appropriate tax form will be issued to the winner by SGI. The Maryland Lottery will notify SGI of the winner and provide winner's contact information to SGI once the winner has claimed and been verified. The Trip Prize must be completed within 18 months from the date that the winner claims the Trip Prize.

The winner, once approved for the Trip Prize, will receive in the mail a detailed registration package containing all travel rules and guidelines.

The winner will be required to book all Trip Prize-related travel (hotel, air, excursions, etc.) a minimum of 60 days prior to the date of the preferred departure date. All bookings are based on availability at the time of booking.
