



## **MY LOTTERY REWARDS™ POINTS FOR DRAWINGS® Las Vegas Vacation Drawing Rules**

**ENTRY DATES:** Tuesday, January 4, 2022 at 00:00:00 AM Eastern Time ("ET") – Monday, April 4, 2022 at 11:59:59 PM ET.

**DRAWING DATE:** Tuesday, April 5, 2022

**CLAIMING DEADLINE:** Winner: May 5, 2022; Alternate: June 6, 2022

**POINTS REQUIRED FOR ENTRY:** 50 Draw Points

**WINNERS:** 1

**ESTIMATED TOTAL PRIZE VALUE:** \$13,104.09 (Includes estimated State and Federal tax withholdings)

### **PRIZE DETAILS:**

#### **Las Vegas Vacation Trip Prize ("Trip Prize"):**

This Trip Prize includes:

- A five (5) day, four (4) night vacation for two (winner and guest) to Las Vegas;
- Roundtrip economy class airfare for two (winner and guest) from any major city with an international airport in the USA or Canada to Las Vegas McCarron Airport (LAS);
- Four Star hotel accommodations for two (winner and guest) for five (5) days/four (4) nights prior to December 31, 2024 (based on availability);
- Breakfast daily, parking, portage, taxes and gratuities;
- Five (5) day car rental;
- \$500.00 cash Meal Allowance; and
- \$1,000.00 Entertainment Allowance for shows, tours, excursions booked through tour agency; unused Entertainment Allowance will not be returned as cash.

**Note:** The winner or the guest must be at least 21 years old.

#### **Claiming:**

You will be advised, at the time of notification, of claiming procedures and reminded of claiming deadlines.

If a winner has been disqualified, or by the relevant claiming deadline has not claimed, submitted all required documentation and information, including submitting completed associated **waivers for both the winner and the guest**, and been confirmed and validated as eligible, then an Alternate may be selected. A decision to replace a winner with an Alternate is within the sole discretion and judgment of the Maryland Lottery. Once the decision to proceed with an Alternate is made, the person who was previously selected as a winner is no longer entitled to the Trip Prize. Alternates must claim by 4:30 PM

on the claiming deadline designated for the Alternate, following the same procedure as outlined below for winner.

The winner must claim the Trip Prize as follows:

- 1) You must claim your Trip Prize in person at the Maryland Lottery's Baltimore Customer Resource Center, Montgomery Park Business Center, 1800 Washington Boulevard, Suite 330, Baltimore, MD 21230.
- 2) Winner and guest must complete and sign a waiver and release of all liability. Either the winner or the guest must be at least 21 years old; however, both winner and guest must be at least 18 years old. (If guest does not accompany winner to claiming, guest may sign the required Lottery waiver later, but winner must sign at claiming). Additional waivers may be required; SGI will provide its waiver for signing as determined by SGI.
- 3) If you win the Trip Prize and you owe State Obligations, which include but are not limited to child support and certain other obligations to a State agency or other governmental entity, then:
  - a. If you owe less than \$500.00 (the cash Meal Allowance portion of the prize) the cash Meal Allowance of the Trip Prize (\$500.00) will be applied first to those State Obligations.
  - b. If you owe more than \$500.00, you have options:
    - i. The Lottery will apply the \$500.00 cash Meal Allowance of the Trip Prize to your State Obligations and you must pay the rest within 5 days; or
    - ii. You can decline the Trip Prize and sign a Refusal of Prize and Waiver and Release of all Liability, and an Alternate may be selected; or
    - iii. If you do not pay off all of those outstanding State Obligations within five (5) business days of claiming the Trip Prize, then you will be disqualified and an Alternate may be selected. See MLR Terms of Use (link provided below) for further provisions.
- 4) In the event of a winner's death or inability to partake of the Trip Prize, the Lottery will make a determination about the awarding of the Trip Prize. The Lottery's decision will be final.
- 5) You do not have the option to request or receive a substitute or equivalent prize for any Trip Prize.

Scientific Games International, Inc. or its subcontractor(s) (hereinafter "SGI") will completely fulfill the Trip Prize and pay the required estimated State and Federal tax withholdings. A W-2G or other appropriate tax form will be issued to the winner by SGI. The Maryland Lottery will notify SGI of the winner and provide winner's contact information to SGI once the winner has claimed and been validated. The Trip Prize must be completed by December 31, 2024.

The winner, once approved for the Trip Prize, will receive in the mail a detailed registration package containing all travel rules and guidelines.

The winner will be required to book all Trip Prize-related travel (hotel, air, excursions, etc.) a minimum of 60 days prior to the date of the preferred departure date. All bookings are based on availability at the time of booking.
