**CLAIMING DEADLINE:** February 3, 2023; Alternate March 6, 2023

**POINTS REQUIRED FOR ENTRY:** 50 Draw Points

#### **PRIZE DETAILS:**

Winner to select one of three vacation prize package ("Trip Prize") options listed below. **NOTE:** The winner or the guest must be at least 21 years old, have valid driver's license and car insurance. Proof of Covid-19 vaccination may be required for portions of the trip.

<u>Colorado Springs, CO</u> - Includes 4-day/3-night stay five-star accommodations at the Broadmoor in Colorado Springs, CO; breakfast daily; \$400 resort credit that can be used towards dinners, drinks, golf, spa treatments or any other resort-based activity; 4-day rental car; Roundtrip airfare. **Prize Cost:** \$14,570.63 (Including payment of estimated tax withholdings)

<u>Sonoma, CA</u>- Includes 4-day/3-night stay at Four Star Fairmont Sonoma Mission Inn & Spa; breakfast daily; private 5-hour vineyard tour in chauffeured luxury sedan; \$300 allowance that can be used towards wine tastings; \$300 resort credit that can be used towards drinks, dinner, golf or spa treatment; 4-day full size rental car; roundtrip airfare. **Prize Cost: \$14,788.10** (*Including payment of estimated tax withholdings*)

#### -OR-

<u>Orlando, FL</u> - Includes 5-day/4-night stay at Four Star Renaissance Orlando, breakfast daily, 3-day Disney theme park tickets for two (one park per day); 1-day admission to SeaWorld for two; 5-day rental car; roundtrip airfare. **Prize Cost: \$14,788.10** (Including payment of estimated tax withholdings)

## **CLAIMING:**

You will be advised, at the time of notification, of claiming procedures and reminded of claiming deadlines.

If a winner has been disqualified, or by the relevant claiming deadline has not claimed, submitted all required documentation and information, including submitting completed associated waivers for both the Winner and the guest, and been confirmed and validated as eligible, then an Alternate may be selected. A decision to replace a winner with an Alternate is within the sole discretion and judgment of the Maryland Lottery. Once the decision to proceed with an Alternate is made, the person who was previously selected as a winner is no longer entitled to the Trip Prize. Alternates must claim by 4:30 PM on the claiming deadline designated for the Alternate, following the same procedure as outlined below for winner.

The Winner must claim the Trip Prize as follows:

- 1) You must claim your Trip Prize in person at the Maryland Lottery's Baltimore Customer Resource Center, Montgomery Park Business Center, 1800 Washington Boulevard, Suite 330, Baltimore, MD 21230.
- 2) Winner and guest must complete and sign a waiver, provide photo I.D. proof, and release of all liability. Either the Winner or the guest must be at least 21 years old; however, both winner and guest must be at least 18 years old. (If guest does not accompany winner to claiming, guest may sign the required Lottery waiver later, but winner must sign at claiming). Additional waivers may be required; SGI will provide its waiver for signing as determined by SGI.
- 3) If you win the Trip Prize and you owe State Obligations, which include but are not limited to child support and/or certain other obligations to a State agency or other governmental entity, then:
  - a. You must pay your State Obligations within 5 days; or
  - b. You can decline the Trip Prize and sign a Refusal of Prize and Waiver and Release of all Liability, and an Alternate may be selected; or
  - c. If you do not pay off all of those outstanding State Obligations within five (5) business days of claiming the Trip Prize, then you will be disqualified and an Alternate may be selected. See MLR Terms of Use (link provided below) for further provisions.
- 4) In the event of a Winner's death or inability to partake of the Trip Prize, the Lottery will make a determination about the awarding of the Trip Prize. The Lottery's decision will be final.
