



Maryland Lottery® My Lottery Rewards™ Frogger Second-Chance Promotion

Drawing Rules

OVERVIEW:

Beginning any time on Monday, March 20, 2023, until 11:59:59 PM Eastern Time (“ET”) on Monday, May 22, 2023, players can enter the Frogger Second-Chance Promotion (“Promotion”) offered by the Maryland State Lottery and Gaming Control Agency (“Lottery” or “Maryland Lottery”) for a chance to win an Arcade1Up™ Frogger Special Edition Arcade Machine (“Prize”). The Lottery will conduct one (1) second-chance drawing (“Drawing”) through the Promotion to select three (3) winners to each win the Prize. The Drawing will be conducted on Tuesday, May 23, 2023.

ENTRY DATES:

Monday, March 20, 2023 through Monday, May 22, 2023.

DRAWING DATE:

Tuesday, May 23, 2023

ESTIMATED TOTAL PRIZE VALUE: \$1,097.15 (includes delivery fee)

CLAIMING DEADLINES:

4:30 PM ET: Winner June 23, 2023; Alternate July 24, 2023

HOW TO ENTER:

To participate, enter **through My Lottery Rewards (“MLR”) at mdlottery.com/rewards, through the MLR App or at mdlottery.com/frogger** any non-winning Maryland Lottery® Frogger scratch-off ticket (Game #627) and/or any other ticket specified by the Lottery (singular “Ticket”; plural “Tickets”).

Entries must be entered for the Drawing by 11:59:59 PM Eastern Time on its announced Drawing Entry Deadline date to be eligible for that Drawing. (In these Rules, all times are Eastern Time.) To enter and to win, you must be 18 years of age or older. A Drawing may include any random selection event. This is a bonus drawing, and the Prize is a bonus prize.

Internet access and a valid email address are required for you to enter this Promotion and its Drawings. Mailed entries will not be accepted. You may enter as often as you like, but:

- You may only win once, and
- Only one winner per household is allowed.

You do not need to keep your original ticket to claim your prize if you win. (Players and winners are sometimes referred to as “you” and “your”.) A Ticket may only be used to enter one time. Players will automatically receive one (1) entry per Ticket into the Promotion, and progress towards MLR achievements.

All winners, including alternate winners (“Alternates”), must claim your prize by 4:30 PM on the respective claiming deadline dates shown above. Entries received after the final Drawing entry deadline will be ineligible and void.

PRIZE DESCRIPTION

The Arcade1Up™ Frogger Special Edition Arcade Machine includes three games in one: Frogger, Time Pilot and Time Pilot '84. The Prize comes with a full color 17" display, full-size joystick and buttons, and volume control. Dimensions when assembled are 19" width x 22.75" height x 57.8" depth.

CLAIMING:

Winners must claim your prize as follows:

- Winners may claim their prize in person at the Maryland Lottery Baltimore Customer Resource Center, 1800 Washington Boulevard, Suite 330, Baltimore, MD 21230 or by mail, fax or email (with a claim form and required documentation) using the same mailing address; An email address and/or fax number upon request.
- If a winner has been disqualified, or by the relevant claiming deadline has not claimed and submitted all required documentation and information, and been confirmed and validated as eligible then an Alternate winner may be selected. Alternates must claim by 4:30 PM on the respective claiming deadline designated for Alternates.
- You do not have the option to request or receive a substitute or equivalent prize for any prize.
- If the name of the person who claims does not match the name on the Internet entry, then that person cannot claim and, upon validation by the person whose name is on the Internet entry, the prize will be awarded to the person whose name was listed on the Internet entry.

You will be advised, at the time of notification, of claiming procedures and reminded of claiming deadlines.

PRIZE FULFILLMENT AND DELIVERY

Once a winner has claimed their prize, and the Lottery has verified the winner's eligibility, the information provided by the winner will be provided to Pollard Banknote Limited ("PBL") by a Communications representative. PBL will contact the winner and provide winner with all necessary information for fulfillment; including scheduling delivery of the Prize. Delivery company will bring the Prize inside the winner's house and unpack the shipping materials. The winner will then have to assemble the Prize.

The Maryland Lottery will send you a W-2G form. All amounts paid to you or on your behalf will be included in your reportable income. You will be taxed on those amounts. All winners are responsible for all taxes, including income taxes.
