



## Maryland Lottery® My Lottery Rewards™ Instant Lottery Second-Chance Promotion

### Drawing Rules

#### **OVERVIEW:**

Beginning any time on Monday, February 20, 2023, until 11:59:59 PM Eastern Time (“ET”) on Monday, June 5, 2023, players can enter the Instant Lottery Second-Chance Promotion (“Promotion”) offered by the Maryland State Lottery and Gaming Control Agency (“Lottery” or “Maryland Lottery”) for a chance to win a cash prize of \$10,000. The Lottery will conduct a series of five (5) second-chance drawings (“Drawings” or, individually, “Drawing”) throughout the Promotion to select a total of five (5) winners to each win \$10,000. An estimated total of up to \$50,000 in cash prizes will be awarded for this Promotion. See below for more information.

#### **HOW TO PARTICIPATE:**

To participate, enter through **My Lottery Rewards (“MLR”) at [mdlottery.com/rewards](https://mdlottery.com/rewards), through the MLR App or at [mdlottery.com/instantlottery](https://mdlottery.com/instantlottery)** any non-winning Maryland Lottery® Instant Lottery scratch-off ticket (Game #621) and/or any other ticket specified by the Lottery (singular “Ticket”; plural “Tickets”).

For each Drawing: Entries must be entered for a specific Drawing by 11:59:59 PM Eastern Time on its announced Drawing Entry Deadline date to be eligible for that Drawing. (In these Rules, all times are Eastern Time.) Entries are not cumulative. Each Drawing must be entered individually to participate in that Drawing. **See the Drawing Chart below for Drawing Number, Drawing Start Date, Drawing Entry Deadlines, Drawing Dates, Number of Winners, Prizes, and Claiming Deadlines.**

A Drawing may include any random selection event. These are bonus drawings, and the prizes are bonus prizes.

Internet access and a valid email address are required for you to enter this Promotion and its Drawings. Mailed entries will not be accepted. You may enter as often as you like, but:

- You may only win once throughout the Promotion, and
- Only one winner per household is allowed throughout Promotion.

You do not need to keep your original ticket to claim your prize if you win. (Players and winners are sometimes referred to as “you” and “your”.) A Ticket may only be used to enter one time. Players will automatically receive one (1) entry per Ticket into the Promotion, and progress towards MLR achievements.

To enter and to win, you must be 18 years of age or older.

**CLAIMING:**

Winners must claim your prize as follows:

- Winners must claim your prize in person **by 4:30 PM on the respective claiming deadline date** at the Maryland Lottery Baltimore Customer Resource Center, Montgomery Park Business Center, 1800 Washington Boulevard, Suite 330, Baltimore, MD 21230.
- If a winner has been disqualified, or by the relevant claiming deadline has not claimed and submitted all required documentation and information, and been confirmed and validated as eligible then an Alternate winner may be selected. Alternates must claim by 4:30 PM on the respective claiming deadline designated for Alternates.
- You do not have the option to request or receive a substitute or equivalent prize for any prize.
- If the name of the person who claims does not match the name on the Internet entry, then that person cannot claim and, upon validation by the person whose name is on the Internet entry, the prize will be awarded to the person whose name was listed on the Internet entry.

You will be advised, at the time of notification, of claiming procedures and reminded of claiming deadlines. Claiming deadlines for winners, including Alternates, are included in the chart above.
