PRIZE DETAILS:

Winner to select one of three 2024 awards show vacation prize packages ("Trip Prize") listed below. The winner or the guest must be at least 21 years old to check into the hotel. Proof of Covid-19 vaccination may be required for portions of the trip.

Excellence in Sports Performance Yearly ("ESPY") Awards – The ESPY Awards celebrate the best players, teams and moments in the world of sports. <u>American Music Awards ("AMAs")</u> - The AMAs are an annual music awards show. This Trip Prize includes a 4-day/3night stay at a 4-star hotel in Los Angeles, CA; breakfast daily; two orchestra-level tickets to the2024 AMAs on a date TBD; roundtrip airfare and airport transfers in Los Angeles; \$500 spending money. **Prize Cost: \$15,966.54** (Including payment of estimated tax withholdings)

<u>Primetime Emmy Awards ("Emmys")</u> - The Emmys recognize excellence in primetime television. This Trip Prize includes a 4-day/3-night stay at a 4-star hotel in Los Angeles, CA; breakfast daily; two mezzanine-level tickets to the 2024 Emmys on a date TBD; roundtrip airfare and airport transfers in Los Angeles; \$500 spending money. **Prize Cost: \$16,727.70** (Including payment of estimated tax withholdings)

CLAIMING:

You will be advised, at the time of notification, of claiming procedures and reminded of claiming deadlines. If a winner has been disqualified, or by the relevant claiming deadline has not claimed, submitted all required documentation and information, including submitting completed associated **waivers for both the Winner and the guest**, and been confirmed and validated as eligible, then an Alternate may be selected. A decision to replace a winner with an Alternate is within the sole discretion and judgment of the Maryland Lottery. Once the decision to proceed with an Alternate is made, the person who was previously selected as a winner is no longer entitled to the Trip Prize. Alternates must claim by 4:30 PM ET on the claiming deadline designated for the Alternate, following the same procedure as outlined below for winner.

The Winner must claim the Trip Prize as follows:

- 1) You must claim your Trip Prize in person at the Maryland Lottery's Baltimore Customer Resource Center, Montgomery Park Business Center, 1800 Washington Boulevard, Suite 330, Baltimore, MD 21230.
- 2) Winner and guest must complete and sign a waiver, provide photo I.D. proof, and release of all liability. Winner and guest must be at least 18 years old. (If guest does not accompany Winner to claiming, guest may sign the required Lottery waiver later, but Winner must sign at claiming). Additional waivers may be required; SG will provide its waiver for signing as determined by SG.
- 3) If you win the Trip Prize and you owe State Obligations, which include but are not limited to child support and/or certain other obligations to a State agency or other governmental entity, then:
 - a. If you owe less than \$500 (the cash portion of the prize) the cash portion of the Trip Prize (\$500) will be applied first to those State Obligations.
 - b. If you owe more than \$500, you have options:
 - i. The Lottery will apply the \$500 of the Trip Prize to your State Obligations and you pay the rest within 5 days; or
 - ii. You can decline the Trip Prize and sign a Refusal of Prize and Waiver and Release of all Liability, and an Alternate may be selected; or
 - iii. If you do not pay off all of those outstanding State Obligations within five (5) business days of claiming the Trip Prize, then you will be disqualified and an Alternate may be selected. See MLR Terms of Use (link provided below) for further provisions.
- 4) In the event of a Winner's death or inability to partake of the Trip Prize, the Lottery will make a determination about the awarding of the Trip Prize. The Lottery's decision will be final.
- 5) You do not have the option to request or receive a substitute or equivalent prize for any Trip Prize.
