



## Maryland Lottery® My Lottery Rewards™ Sheetz® Gift Card Giveaway Second-Chance Promotion Drawing Rules

### OVERVIEW:

Beginning any time on May 8, 2023 until 11:59:59 PM Eastern Time ("ET") on June 26, 2023 ("Promotion Period"), players can enter \$10 Powerball® tickets purchased at participating Sheetz®, Inc. ("Sheetz") locations into the My Lottery Rewards™ Sheetz® Gift Card Giveaway Second-Chance Promotion ("Promotion") offered by the Maryland State Lottery and Gaming Control Agency ("Lottery" or "Maryland Lottery"). Players have the chance to win up to \$1,500 in Sheetz Cards ("Cards", or "Card"). Cards can be used towards gas and other merchandise at Sheetz®, but may not be used to purchase Lottery tickets. Seven (7) drawings ("Drawings" or, individually, "Drawing") will be held throughout the Promotion to select a total of thirty-one (31) winners. A total of \$11,000 in prizes in the form of Cards ("Prizes" or, individually "Prize") will be awarded. See below for more information.

### PRIZES:

Two (2) winners will be selected to each receive three (3) Cards pre-loaded with \$500 each for a total of \$1,500 in Cards; one (1) winner will be selected to receive two (2) Cards pre-loaded with \$500 each for a total of \$1,000 in Cards; and twenty-eight (28) winners will be selected to each receive one (1) Card pre-loaded with \$250. Cards are valid for at least one year from the date winner receives the Card. *\*This prize is for a Sheetz card which may be used for gas as well as other merchandise at Sheetz locations, but may not be used to purchase Lottery tickets.*

### HOW TO ENTER:

To participate, enter at [mdlottery.com/sheetz](https://mdlottery.com/sheetz) one winning or non-winning Maryland Lottery® Powerball® ticket in the amount of \$10 on a single ticket purchased from any participating Sheetz location in Maryland during the Promotion Period ("Ticket" or "Tickets"). Each \$10 Ticket entered equals one (1) entry into the drawing. (A \$10 Ticket equals one (1) entry into the drawing, two \$10 Tickets equals two (2) entries into the drawing, three \$10 Tickets equals three (3) entries into the drawing, etc.)

Entries are cumulative. Once an entry is submitted, it will remain in the pool of entries unless selected as a winning entry. For each drawing: Entries must be entered for a specific drawing by 11:59:59 PM ET on the announced Drawing Entry Deadline date (see above) to be eligible for that drawing. (In these Sheetz® Gift Card Giveaway Second Chance Promotion Drawing Rules ("Rules"), all times are Eastern Time.) A drawing may include any random selection event. These are bonus drawings.

Internet access and a valid email address are required to enter this Promotion and its Drawings. Mailed entries will not be accepted. You may enter as often as you like; however, you may only win once throughout the Promotion. Only Tickets purchased and entered during the Promotion Period are valid entries. For second-chance Drawings, you do not need to keep your original Ticket(s) in order to claim your prize if you win. (Players and winners are sometimes referred to as "you" and "your".) A Ticket may only be used to enter one (1) time.

#### **CLAIMING:**

You will be advised, at the time of notification, of claiming procedures and reminded of claiming deadlines. Claiming deadlines for winners, including alternates, are included in the chart above.

Winners of the **\$1,500** and **\$1,000** Cards must claim your prize in person by 4:30 PM of the claiming deadline date listed in the chart above at the Lottery's Baltimore Customer Resource Center, Montgomery Park Business Center, 1800 Washington Boulevard, Suite 330, Baltimore, MD 21230.

- If you owe State Obligations, which include but are not limited to child support and/or certain other obligations to a State agency or other governmental entity, then you must pay those outstanding State Obligations in order for the prize to be awarded to you. If any of those outstanding State Obligations are not paid off within five (5) business days of claiming the prize, then you will be disqualified, and an alternate winner may be selected.
- You will receive a W-2G form from the Lottery. All amounts paid to you or on your behalf will be included in your reportable income. You will be taxed on those amounts. All winners are responsible for all taxes, including income taxes.

Winners of the **\$250** Cards will be contacted by a Lottery representative via email, telephone and/or mail to confirm your mailing address. This prize will then be automatically fulfilled by Scientific Games, LLC, (formerly Scientific Games International, Inc. (hereinafter "SGI") and identified as such in the Official Rules, indicated below) ("SG").

If a winner has been disqualified, or by the relevant claiming deadline has not claimed, submitted all required documentation and information, and been confirmed and validated as eligible, then an alternate winner may be selected. Alternates must claim by 4:30 PM on the respective claiming deadline date designated for alternates.

Winners do not have the option to request or receive a substitute or equivalent prize for any prize.

If the name of the person who claims does not match the name on the Internet entry, then that person cannot claim and, upon validation by the person whose name is on the Internet entry, the prize will be awarded to the person whose name was listed on the Internet entry.

#### **OTHER OFFICIAL RULES:**

If any discrepancy should exist between these Rules and any other material describing this Promotion or anything related thereto, these Rules shall prevail.

All aspects of this Promotion are governed by these Rules and any amendments thereto.
