**PRIZE DETAILS:**

**Whistler, British Columbia Vacation** – The town of Whistler is home to Whistler Blackcomb, one of the largest ski resorts in North America, offering winter recreations such as skiing, snowboarding, and snowshoeing and summer recreations such as hiking, biking, and sightseeing. The center is a chalet-style pedestrian village at the base of Whistler and Blackcomb mountains offering shopping and dining. Winner can choose the time of year they'd like to vacation.

The vacation prize for one winner and one guest includes:

- 5 days / 4 nights Five Star accommodations at the Fairmont Whistler in British Columbia, with daily breakfast, portage, and all taxes and gratuities included.
- \$800 EDGE Card (Resort Credit) for skiing/snowboarding in winter, or riding bike park in summer, or other resort-based activities. The card can only be used during trip.
- Roundtrip airport transfers to and from Vancouver International Airport and the Fairmont Hotel.
- Roundtrip economy class airfare from any major city with an international airport in the USA to Vancouver International Airport in British Columbia, Canada.

**CLAIMING:**

You will be advised, at the time of notification, of claiming procedures and reminded of claiming deadlines.

If a winner has been disqualified, or by the relevant claiming deadline has not claimed, submitted all required documentation and information, including submitting completed associated **waivers for both the winner and the guest**, and been confirmed and validated as eligible, then an Alternate may be selected. A decision to replace a winner with an Alternate is within the sole discretion and judgment of the Maryland Lottery. Once the decision to proceed with an Alternate is made, the person who was previously selected as a winner is no longer entitled to the Trip Prize. Alternates must claim by 4:30 PM on the claiming deadline designated for the Alternate, following the same procedure as outlined below for winner.

The winner must claim the Trip Prize as follows:

- 1) You must claim your Trip Prize in person at the Maryland Lottery's Baltimore Customer Resource Center, Montgomery Park Business Center, 1800 Washington Boulevard, Suite 330, Baltimore, MD 21230.
- 2) Winner and guest must complete and sign a waiver and release of all liability. Either the winner or the guest must be at least 21 years old; however, both winner and guest must be at least 18 years old. (If guest does not accompany winner to claiming, guest may sign the required Lottery waiver later, but winner must sign at claiming). Additional waivers may be required; SG will provide its waiver for signing as determined by SG.
- 3) Winner and guest must possess a valid passport, passport card, or NEXUS card to enter Canada.
- 4) If you win the Trip Prize and you owe State Obligations, which include but are not limited to child support and certain other obligations to a State agency or other governmental entity, then:
  - a. You must pay your State Obligations within 5 days; or
  - b. You can decline the Trip Prize and sign a Refusal of Prize and Waiver and Release of all Liability, and an Alternate may be selected; or
  - c. If you do not pay off all of those outstanding State Obligations within five (5) business days of claiming the Trip Prize, then you will be disqualified and an Alternate may be selected. See MLR Terms of Use (link provided below) for further provisions.
- 5) In the event of a winner's death or inability to partake of the Trip Prize, the Lottery will make a determination about the awarding of the Trip Prize. The Lottery's decision will be final.
- 6) You do not have the option to request or receive a substitute or equivalent prize for any Trip Prize.
