



## Maryland Lottery® My Lottery Rewards™ Keno Ice Cold Cash Second-Chance Promotion Drawing Rules

### **OVERVIEW:**

Beginning on Monday, January 15, 2024, at 00:00:00 AM Eastern Time (ET), until Sunday, February 11, 2024 at 11:59:59 PM ET (“Promotion Entry Period”), players can participate in the Maryland State Lottery and Gaming Control Agency (“Lottery” or “Maryland Lottery”) Keno Ice Cold Cash Second-Chance Promotion (“Promotion”) by entering eligible Keno Tickets (defined below) into My Lottery Rewards™ for a chance to be selected as a winner (“Winner”) in the Promotion. A series of four (4) drawings (“Drawings”, individually “Drawing”) will be held during the promotion period. Each Winner will win a cash prize between \$2,500 and \$10,000 depending on the lowest recorded temperature by the National Weather Service (“NWS”) during the seven (7) days prior to the drawing date. The Lottery will review the prior week’s temperatures recorded by the NWS to determine the day with the lowest recorded temperature during the seven (7) days prior to the Drawing date (“Temperature Review Dates”). That day’s lowest recorded temperature will be used to determine the prize amount for that week’s Drawing (see temperature and prize chart below.)

### **HOW TO PARTICIPATE:**

To participate, players may enter through the Maryland Lottery website, [mdlottery.com/promotion/keno-ice-cold-cash](https://mdlottery.com/promotion/keno-ice-cold-cash), or through **My Lottery Rewards (“MLR”)** [mdlottery.com/rewards](https://mdlottery.com/rewards), or through the **MLR App**, winning and non-winning Maryland Lottery® Keno tickets, purchased between January 15, 2024 and February 11, 2024. Entries into the Promotion are based on the Dollar value of the ticket(s) entered: one Dollar’s (\$1.00) worth of Tickets entered equals one (1) entry into the Promotion, two Dollar’s (\$2.00) worth of Tickets entered equals two (2) entries into the Promotion, and so on. Keno tickets can be entered the day after purchase, or after the first draw on a multi-draw ticket, whichever comes first, unless the ticket has been cancelled.

All entries are cumulative, which means if you submit an entry within the Promotion Entry Period and prior to a particular drawing’s Drawing Entry Deadline, it will be eligible for that drawing and all subsequent drawings in this promotion, unless selected as a winning entry. Entries must be entered by 11:59:59 PM ET on the announced Drawing Entry Deadline date in order to be included in that Drawing. (In these Drawing Rules (“Rules”), all times are EST.) See the Drawing Chart below for Drawing Number, Drawing Entry Start Date, Drawing Entry Deadline, Drawing Date, Temperature Review Dates, Number of Winners selected for that Drawing, and Claiming Deadline. A drawing may include any random selection event. These are bonus Drawings with bonus prizes. Internet access and a valid email address are required to enter this Promotion and its Drawings. Mailed entries will not be accepted. You may enter as often as you like, and:

- You may only win one time throughout the Promotion; and
- Only one Winner per household/residence address (as registered with MLR at the time of the Drawing) is allowed per Drawing.

You do not need to keep your original ticket in order to claim your prize if you win. (Players, or Winners are sometimes referred to as “you” and “your”.) A qualifying entry is \$1 worth of Keno ticket(s). A ticket may only be used to enter the Promotion one time.

To enter and to win, you must be 18 years of age or older. The name, hometown, and state of each Winner will be announced at [mdlottery.com/rewards](http://mdlottery.com/rewards) and at [mdlottery.com](http://mdlottery.com).

**PRIZE:**

The prize amount will be determined by the lowest recorded temperature at BWI by the National Weather Service (“NWS”), as updated at [www.weather.gov](http://www.weather.gov), during the corresponding Temperature Review Dates. See the Prize Chart below for the prize amount associated with each temperature range. The day with the lowest temperature recorded during the corresponding Temperature Review Dates will be used to calculate the Prize Amount.

LOWEST RECORDED TEMPERATURE FAHRENHEIT, (“F”)	PRIZE AMOUNT
24 degrees (F) and below	\$10,000
25 - 34 degrees (F)	\$7,500
35 - 44 degrees (F)	\$5,000
45 degrees (F) and above	\$2,500

*The lowest temperature recorded used for this Promotion is from the National Weather Service; however, the National Weather Service does not endorse this Promotion or the Maryland Lottery and is not affiliated with the Maryland Lottery in any way.*

**CLAIMING:**

Winners will be advised, at the time of notification, of claiming procedures and reminded of claiming deadlines. Winners for each Drawing must claim their prize in person **by 4:30 PM on the Claiming Deadline for Winners date shown in the Drawing Chart above** at the Maryland Lottery Baltimore Customer Resource Center, Montgomery Park Business Center, 1800 Washington Boulevard, Suite 330, Baltimore, MD 21230 or by mail (with a claim form and required documentation) using the same address. Winners must furnish photo I.D. proof of being at least 18 years of age. The Lottery will fulfill all Prizes. W-2Gs will be provided by the Lottery to all Winners who receive a prize with a value of \$601 or more.

If a Winner has not claimed by 4:30 PM on the date shown in the chart above, their prize will remain in the Lottery's unclaimed prize fund. An alternate will not be designated. An alternate is only designated if a player is selected more than once during one Drawing or if a player is disqualified.
