PRIZE DETAILS:

MARCO ISLAND BEACH RESORT VACATION: The JW Marriott March Island Beach Resort is situated along three miles of pristine private beaches on the Gulf of Mexico. The resort offers a balance of relaxation and elevated fun and entertainment. Sample cuisine from around the globe at the hotel's 12 restaurants, tee off from one of two championship golf courses, take a fitness class, or enjoy the hotel spa's luxury services and massages. Alternates must claim by 4:30 PM on the claiming deadline designated for the Alternate, following the same procedure as outlined below for the Winner.

The winner must claim the Trip Prize as follows:

- You must claim your Trip Prize in person at the Maryland Lottery's Baltimore Customer Resource Center, Montgomery Park Business Center, 1800 Washington Boulevard, Suite 330, Baltimore, MD 21230.
- 2) Winner and guest must complete and sign a waiver, provide photo I.D. proof, and release of all liability. Either the winner or the guest must be at least 21 years old; however, both the Winner and guest must be at least 18 years old. (If guest does not accompany the Winner to claiming, guest may sign the required Lottery waiver later, but the Winner must sign at claiming). Additional waivers may be required; SG will provide its waiver for signing as determined by SG.
- 3) If you win the Trip Prize and you owe State Obligations, which include but are not limited to child support and/or certain other obligations to a State agency or other governmental entity, then:
 - a. You must pay your State Obligations within 5 days; or
 - b. You can decline the Trip Prize and sign a Refusal of Prize and Waiver and Release of all Liability, and an Alternate may be selected; or
