



**Maryland Lottery® My Lottery Rewards™  
Hall-o-WIN Second-Chance Promotion  
Drawing Rules**

**OVERVIEW:**

Beginning any time on Tuesday, October 1, 2024, until 11:59:59 PM on Thursday, October 31, 2024 (“Promotion Entry Period”), players can enter the Maryland Lottery® My Lottery Rewards™ Hall-o-WIN Second-Chance Promotion (“Promotion”) offered by the Maryland State Lottery and Gaming Control Agency (“Lottery” or “Maryland Lottery”) for a chance to win a cash prize of either \$5,000 or \$10,000. A total of ten (10) winners will be selected to win a total of \$75,000 in cash prizes awarded for this Promotion.

**HOW TO PARTICIPATE:**

To participate, enter at [mdlottery.com/hall-o-win](https://mdlottery.com/hall-o-win), through **My Lottery Rewards™ (“MLR”)** [mdlottery.com/rewards](https://mdlottery.com/rewards), or through the **MLR App**, \$1 worth of any winning or non-winning Maryland Lottery® Pick 3, Pick 4, or Pick 5 tickets, in any combination, purchased between October 1, 2024 and October 30, 2024, (“Ticket”, plural “Tickets”). One Dollar’s (\$1.00) worth of Tickets entered equals one (1) entry into the Promotion. Single and remainder \$0.50 tickets will accumulate in players’ MLR accounts to be combined with their next entry.

Entries must be entered by 11:59:59 PM Eastern Time on the announced Drawing Entry Deadline date in order to be included in the Drawing. (In these Drawing Rules (“Rules”), all times are Eastern Time.) See the Drawing Chart below for Drawing Number, Drawing Entry Start Date, Drawing Entry Deadline, Drawing Date, Number of Winners selected for that Drawing, and Claiming Deadline. A drawing may include any random selection event. These are bonus Drawings with bonus prizes. Internet access and a valid email address are required to enter this Promotion and its Drawings. Mailed entries will not be accepted. You may enter as often as you like, and:

- You may only win one time throughout the Promotion; and
- Only one Winner per household/residence address (as registered with MLR at the time of the Drawing) is allowed per Drawing and Promotion.

You do not need to keep your original ticket in order to claim your prize if you win. (Players, or Winners are sometimes referred to as “you” and “your”.) A qualifying entry is \$1 worth of Pick 3, Pick 4, Pick 5

ticket(s), in any combination. Ticket(s) may only be used to enter the Promotion one time.

To enter and to win, you must be 18 years of age or older. The name, hometown, and state of each Winner will be announced at [mdlottery.com/rewards](http://mdlottery.com/rewards) and at [mdlottery.com/hall-o-win](http://mdlottery.com/hall-o-win).

**CLAIMING:**

Winners will be advised, at the time of notification, of claiming procedures and reminded of claiming deadlines. Claiming deadlines for winners, including Alternates, are included in the chart above.

- Winners of the \$10,000 prizes must claim your prize in person **by 4:30 PM on the claiming deadline date** at the Maryland Lottery Baltimore Customer Resource Center, Montgomery Park Business Center, 1800 Washington Boulevard, Suite 330, Baltimore, MD 21230.
- Winners of the \$5,000 prizes may claim your prize in person or by mail (with a Lottery Claim form and required documentation enclosed), at the Maryland Lottery Baltimore Customer Resource Center, Montgomery Park Business Center, 1800 Washington Boulevard, Suite 330, Baltimore, MD 21230 or by email or facsimile transmission (with a Lottery Claim form and required documentation enclosed). An email address and/or fax number will be provided upon request.
- Winners must allow 30 business days after the Lottery receives a claim for delivery of your prize.
- Winners must furnish photo I.D. proof of being at least 18 years of age.
- If a winner has been disqualified, or by the relevant claiming deadline has not claimed, submitted all required documentation and information, and been confirmed and validated as eligible, then an Alternate winner may be selected. Alternates must claim by 4:30 PM of the claiming deadline designated for Alternates. A decision to replace a winner with an Alternate is within the sole discretion and judgment of the Maryland Lottery. Once the decision to proceed with an Alternate is made, the person who was previously selected as a winner is no longer entitled to a prize.
- You do not have the option to request or receive a substitute or equivalent prize for any prize.

The Lottery will fulfill all Prizes. W-2Gs will be provided by the Lottery to all Winners.
