

Maryland Lottery® My Lottery Rewards™ Giant® Holiday Gift Card Giveaway Second-Chance Promotion Drawing Rules

REVISED ON 12/5/2024

OVERVIEW:

Beginning any time on Monday, November 11, 2024 until 11:59:59 PM on Wednesday, January 8, 2025 ("Promotion Entry Period"), players can enter Mega Millions® tickets of \$10 or more, purchased at participating Giant® locations ("Giant"), into the My Lottery Rewards™ Giant® Holiday Gift Card Giveaway Second-Chance Promotion ("Promotion") offered by the Maryland State Lottery and Gaming Control Agency ("Lottery"). Players have the chance to win up to \$1,500 in Giant gift cards. Giant gift cards can be used to purchase groceries, gas, and other merchandise at participating Giant® locations, but may not be used to purchase Lottery products. A series of eight (8) drawings (each, a "Drawing") will be held throughout the Promotion to select a total of seventy (70) winners (each, a "Winner"). A total of \$23,000 in prizes in the form of Giant® gift cards ("Prize") will be awarded. See below for more information.

HOW TO PARTICIPATE:

To participate, players may enter through the Lottery website, mdlottery.com/giant, or through the My Lottery Rewards ("MLR") website, mdlottery.com/rewards, or through the MLR app, winning or non-winning single Mega Millions tickets of \$10 value or higher purchased during the Promotion Period from a Maryland Giant location (each, a "Ticket"). For each \$10 purchase increment up to \$299 on a single Mega Millions ticket, the player will receive one (1) entry into the Promotion (each, an "Entry"). For example, one (1) \$10 Mega Millions ticket equals one (1) Entry, one (1) \$20 Mega Millions ticket equals two (2) Entries, one (1) \$30 Mega Millions ticket equals three (3) Entries, etc. For each single ticket purchase of \$300 or more, the player will receive 50 Entries. Remainders after \$10 increments on each ticket do not aggregate in the player's account for additional entries. Therefore, a Mega Millions ticket of \$1-9 generates zero (0) Entries, a Mega Millions ticket of \$10-19 generates one (one) Entry, a Mega Millions ticket of \$20-29 generates two (2) Entries, and so on until \$299. Multiple tickets cannot be combined to equal \$10 and one (1) Entry.

Entries are cumulative and will be carried over after each drawing, unless selected as a winning Entry. Entries must be entered for a specific Drawing by 11:59:59 PM ET on the announced Drawing Entry Deadline to be eligible for that Drawing. In these Giant® Holiday Gift Card Giveaway Second Chance Promotion Drawing Rules ("Rules"), all times are Eastern Time. See the Drawings Chart below for Drawing Numbers, Drawing Entry Deadlines, Drawing Dates, Number of Winners, Prizes for each Drawing, and Claiming Deadlines for Winners and Alternates.

Internet access and a valid email address are required to enter this Promotion and each Drawing. Mailed entries will not be accepted. Players may enter a Drawing as often as they like, however, they may only win once during the entire Promotion; and, only one (1) Winner per household/residence address (as registered with MLR at the time of the Drawing) is permitted

per Promotion. Only Tickets purchased during the Promotion Period at Maryland Giant locations and entered during the Promotion Period are valid Entries. For second-chance drawings, players do not need to keep the original Ticket(s) in order to claim a Prize. A Ticket may only be used to enter one (1) time.

To enter and to win, you must be 18 years of age or older.

PRIZES:

• Grand Prize – Two (2) Winners will be selected during Drawing #8, each Winner will receive \$1,500 worth of Giant gift cards, in the form of three (3) \$500 Giant gift cards.

- Midway Grand Prize Four (4) Winners will be selected during Drawing #5, each Winner will receive \$1,000 worth of Giant gift cards, in the form of two (2) \$500 Giant gift cards.
- Weekly Prize during each Drawing, eight (8) Winners will be selected, each Winner will
 receive one (1) \$250 Giant gift card. There will be a total of sixty-four (64) Weekly Prize
 Winners selected.

Giant gift cards may be used for groceries, gas, as well as other merchandise at participating Giant locations, but may not be used to purchase Lottery products.

CLAIMING:

Players will be advised, at the time of notification, of claiming procedures and reminded of claiming deadlines. Claiming deadlines for Winners, including Alternates, are included in the chart above.

Winners of the Grand Prize - \$1,500 Giant® Gift Card and the Midway Grand Prize - \$1,000 Giant® Gift Card must claim the Prize in person by 4:30 PM of the claiming deadline date listed in the Drawings Chart above at the Lottery's Baltimore Customer Resource Center, Montgomery Park Business Center, 1800 Washington Boulevard, Suite 330, Baltimore, MD 21230.

- If a player owes State Obligations, which include but are not limited to child support
 and/or certain other obligations to a State agency or other governmental entity, then the
 player must pay those outstanding State Obligations in order for the prize to be awarded
 to the player. If any of those outstanding State Obligations are not paid off within five (5)
 business days of claiming the prize, then the player will be disqualified, and an Alternate
 may be selected.
- Winners will receive a W-2G form from the Lottery. All amounts paid to the Winner or on the Winner's behalf will be included in the Winner's reportable income. The Winner will be taxed on those amounts. All Winners are responsible for all taxes, including income taxes.

Winners of the **Weekly Prize** - **\$250 Giant**® **Gift Card** will be contacted by a Lottery representative via email, telephone, and/or mail to confirm their mailing address. This Prize will then be automatically fulfilled by Scientific Games, LLC ("SG"), formerly Scientific Games International, Inc. ("SGI"), and mailed to the Winner.

If a Winner has been disqualified, failed to claim the Prize by the applicable claiming deadline, failed to submit all required documentation and information, or otherwise not been confirmed and validated as eligible, an Alternate may be selected. Alternates must claim their Prize by 4:30 PM on the respective claiming deadline date designated for Alternates.

Winners do not have the option to request or receive a substitute or equivalent prize for any Prize.

The Winner's name, when claiming the Prize, must match the name listed on the internet entry.

OTHER OFFICIAL RULES:

If any discrepancy should exist between these Rules and any other material describing this Promotion or anything related thereto, these Rules shall prevail.

All aspects of this Promotion are governed by these Rules and any amendments thereto.
