

# MARYLAND LOTTERY<sup>®</sup> MY LOTTERY REWARDS<sup>™</sup> Back to the Future<sup>™</sup> Second-Chance Promotion <u>DRAWING RULES</u>

#### OVERVIEW:

Beginning any time on Monday, March 24, 2025, until 11:59:59 PM on Monday, July 14, 2025, players can enter the Maryland Lottery<sup>®</sup> My Lottery Rewards<sup>™</sup> Back to the Future<sup>™</sup> Second-Chance Promotion ("Promotion") offered by the Maryland State Lottery and Gaming Control Agency ("Lottery" or "Maryland Lottery") for a chance to win cash prizes. This Promotion will consist of five (5) second-chance drawings ("Drawing"; "Drawings"), during which twenty-one (21) cash prizes will be awarded to eligible players ("Winner"; "Winners"), for an estimated total of \$48,638.

#### HOW TO PARTICIPATE:

To participate, enter at **mdlottery.com/backtothefuture**, or **mdlottery.com/rewards**, or through the **MLR app** non-winning Maryland Lottery<sup>®</sup> Back to the Future<sup>™</sup> Scratch-Off tickets, and/or any other ticket specified by the Lottery, ("Ticket"; "Tickets"). Each Ticket entered will earn the player one (1) entry into the Promotion, as well as progress toward active My Lottery Rewards ("MLR") achievements. A Ticket may only be used to enter one time.

Prizes:

- \$8,888 Cash Prize Relating to the speed at which the Time Machine needs to be traveling to activate time travel, 88mph, the Lottery will award one (1) \$8,888 cash grand prize during the final Drawing.
- \$2,025 Cash Prize One (1) Winner during each of the five Drawings will be selected to win a \$2,025 cash prize. This number commemorates 2025 as the 40<sup>th</sup> anniversary of the Back to the Future<sup>™</sup> movie.
- \$2,015 Cash Prize One (1) Winner during each of the five Drawings will be selected to win a \$2,015 cash prize. This number references the year (2015) in the future to which the main protagonists of the movie time travel.
- \$1,955 Cash Prize Two (2) Winners during each of the five Drawings will be selected to win a \$1,955 cash prize. This number references the year (1955) to which one of the protagonists travels back in time.

#### For each Drawing:

Entries are not cumulative and will not carry over after each Drawing. Entries must be entered for a specific Drawing by 11:59:59 PM Eastern Time on the announced **Drawing Entry Deadline** to be eligible for that Drawing. (In these Drawing Rules, all times are Eastern Time ("ET").) Each Drawing must be entered individually. **See the Drawing Chart below for Drawing Number, Drawing Entry Deadlines, Drawing Dates, Number of Winners, Prizes, and Claiming Deadlines**.

Internet access and a valid email address are required to create a My Lottery Rewards account and enter this Promotion and its Drawings. Mailed entries will not be accepted. Winners in each Drawing will be

drawn starting with the highest prize value first, followed by the next highest, etc. The \$8,888 Cash Prize is the highest prize. Players may enter this Promotion as many times as they would like, and:

- A player may win more than once throughout the Promotion; however,
- A player may only win one time per Drawing; and
- Only one player per household/residence address (as registered with MLR at the time of the Drawing) is allowed to win per Drawing.

You do not need to keep your original ticket in order to claim your prize if you win. (Players and winners are sometimes referred to as "you" and "your".)

Winners' names and cities of residence will be published on the Maryland Lottery<sup>®</sup> and the My Lottery Rewards websites.

To enter, you must be 18 years of age or older. All winners must be at least 18 years of age.

## CLAIMING:

You will be advised, at the time of notification, of claiming procedures and reminded of Claiming Deadlines. Claiming Deadlines for Winners, including Alternates, are included in the chart above.

- Winners must claim your prize in person by 4:30 PM of the claiming deadline date at the Maryland Lottery Customer Resource Center, Montgomery Park Business Center, 1800 Washington Boulevard, Suite 330, Baltimore, MD 21230 by <u>scheduling an appointment</u>, (walk-ins are not permitted), or by mail (with a <u>Lottery Claim Form</u> and required documentation enclosed), to the address previously stated, or through email or facsimile transmission (with a Lottery Claim form and required documentation enclosed). An email address and/or fax number will be provided upon request.
- Winners must allow 30 business days after the Lottery receives a claim for delivery of your prize.
- If a Winner has been disqualified, or by the relevant Claiming Deadline has not claimed, submitted all required documentation and information, and been confirmed and validated as eligible, then an Alternate may be selected. Alternates must claim by 4:30 PM of the Claiming Deadline designated for Alternates. A decision to replace a Winner with an Alternate is within the sole discretion and judgment of the Maryland Lottery. Once the decision to proceed with an Alternate is made, the person who was previously selected as a winner is no longer entitled to a prize.
- You do not have the option to request or receive a substitute or equivalent prize for any prize.

The Maryland Lottery will send each Winner a W-2G form. All amounts paid to you or on your behalf will be included in your reportable income. You will be taxed on those amounts. All winners are responsible for all taxes, including income taxes.
