



**Maryland Lottery® My Lottery Rewards™
Let's Make a Deal® Second-Chance Promotion**

Drawing Rules

OVERVIEW:

Beginning any time on Monday, April 21, 2025, until 11:59:59 PM on Monday, September 8, 2025, ("Promotion Period") players can enter the Let's Make a Deal® Second-Chance Promotion ("Promotion") offered by the Maryland State Lottery and Gaming Control Agency ("Maryland Lottery" or "Lottery") through Maryland Lottery® My Lottery Rewards™ ("MLR") for the chance to win cash or a trip prize. This Promotion will consist of five (5) drawings ("Drawings" or "Drawing"), and the Lottery will select five (5) winners during each Drawing. Players have the chance to win a \$5,000 cash prize or a Let's Make a Deal® VIP Trip ("Trip Prize").

HOW TO PARTICIPATE:

Players can enter at mdlottery.com/letsmakeadeal or mdlottery.com/rewards or through the **My Lottery Rewards App** non-winning Let's Make a Deal® Scratch-Off tickets (game #741), and/or any other ticket specified by the Maryland Lottery, purchased during the Promotion Period (each a "Ticket"). Each Ticket entered will generate one (1) entry into the Promotion as well as progress toward active MLR achievements. A Ticket may only be used once to enter the Promotion.

Entries are cumulative and will carry over from each drawing to the next unless selected as a winning entry. Entries must be entered by 11:59:59 PM by the announced Drawing Entry Deadline date in order to be eligible for that Drawing. (In these Drawing Rules, all times are Eastern Time ("ET").) See the **Drawings Chart** below for Drawing Number, Drawing Entry Start Date, Drawing Entry Deadline Date, Drawing Date, and Claiming Deadline Date for winners and alternates. A Drawing may include any random selection event. This is a bonus drawing, and the prizes are bonus prizes.

All winners, including alternate winners, must claim their prize by 4:30 PM EST on the respective claiming deadline. All entries received after the final Drawing Entry Deadline of 11:59:59 PM, September 8, 2025, will be ineligible and void.

Internet access and a valid email address are required for entry into the Promotion and its Drawings. Mailed entries will not be accepted. To enter and to win, players must be 18 years of age or older. Players may enter the Promotion as many times as they want, and:

- Players may win more than once throughout the Promotion; however,
- Players may only win one (1) time per Drawing; and
- Players may only win one (1) Trip Prize during the Promotion; and
- Only one (1) winner per household/residence address (as registered with MLR at the time of the Drawing) is allowed per Drawing.

All winners' names and town/city of residence will be posted on the Past Drawings & Winners page on the MLR website, and the Maryland Lottery Promotions page, and may be included in the Maryland Lottery's press releases, promotional emails, and/or social media posts.

PRIZE DESCRIPTION:

- I. **Trip Prize:** There will be five (5) Trip Prize winners ("Trip Winner"; "Trip Winners"). Each Trip Winner will be allowed one (1) guest. Each Trip Winner shall receive a four (4) day/ three (3) night trip for two (2) to Los Angeles, California. Trip date shall be on or about **May 12-15, 2026***. The following services will be provided for each Trip Winner and one (1) guest per winner:
- Round trip air transportation to and from Los Angeles, California
 - Transportation from and to the Airport in Los Angeles;
 - The Glenmark Hotel or similar accommodations for three (3) nights in Glendale, California;
 - Ground transportation to and from hosted events during the trip;
 - \$1,660 spending money
 - Hosted VIP tour of Los Angeles landmarks including lunch;
 - Shopping trip to an area costume shop
 - Attendance at a studio taping of an episode of the television show Let's Make a Deal with VIP access; and
 - Participation in the Let's Make a Deal Cash Prize giveaway contest ("Event"), where each Trip Winner will win a guaranteed amount between \$1,000 and \$3,000 (see **Let's Make a Deal Cash Prize Giveaway Event** rules and overview below).

Estimated Trip Prize value: \$6,050.00

***Trip dates are subject to change.**

Travel accommodations for each Trip Winner and guest shall consist of two (2) round trip coach class tickets booked on a major airline, as defined by the Federal Aviation Administration, to Los Angeles, California or vicinity airport, from a major commercial Maryland or vicinity airport, the cost of which shall not exceed \$1,500. The Trip Winners will be responsible for any airfare costs exceeding \$1,500. Any unused portion of the \$1,500 air transportation allowance will be added to the \$1,660 Trip Winner spending money allowance.

Each Trip Winner shall be obligated to comply with all other terms and requirements of the trip package.

The Trip Prize does **not** include: mileage, insurance, gratuities, parking fees, excess baggage fees, alcoholic beverages, any items not expressly specified and personal expenses such as meals, telephone calls, valet service, laundry and the like, as well as revision or cancellation fees which may be charged by other suppliers. Trip Winners may be required to present a valid credit card for incidental charges at the hotel upon check-in.

The Trip Winner or guest must have a valid credit card or shall be required to post cash deposit for incidentals to check into the hotel. The Trip Winner and guest must be eighteen (18) years of age or older to participate in the Event, and the age requirement to check into a hotel in California is twenty-one (21), therefore the Trip Winner or guest must be twenty-one (21) years of age or older.

Trip Winners and guests must sign a waiver and release of all liability provided by the Lottery.

Trip Winner and guest shall be required to comply with the Department of Homeland Security's ("DHS") REAL ID Act and all other programs to attend the event. For more information, please see [DHS's REAL ID webpage](#). If applicable, Trip Winner and guest shall be required to follow all health and safety protocols as instructed by the event's staff and volunteers and all federal, state, and local guidelines.

Trip packages may be transferable from one Trip Winner to a third party one (1) time as agreed by Alchemy and the Lottery. The Trip Winner may not choose to receive the cash equivalent of the trip portion of the Trip Prize.

Let's Make a Deal Cash Prize Giveaway

Contest Rules and Overview

Overview: All five (5) Trip Winners will have the opportunity to win additional cash prizes based on the individual outcomes of Let's Make a Deal ("LMAD") contestants during the taping that they attend. Prizes shall be awarded as follows:

- Each Trip Winner will be assigned a show contestant who will play the LMAD Gameshow during their assigned taping.
- Trip Winner will be assigned show contestants based on the order they were drawn by the Lottery and the order a show contestant is called to play the gameshow.
 - Trip Winner will have their corresponding number on name tag.
- Trip Winner's additional prize will be based on the outcome of their assigned show contestant during the taping.
- There are three (3) possible outcomes for show contestants:
 - **ZONK** – the show contestant selects a curtain, box, or alternate mechanism that reveals a ZONK and is eliminated from further participation.
 - **PRIZE** – the show contestant avoids a ZONK and wins a prize.
 - **The BIG DEAL** – Starting with the highest dollar prize value winner, the host asks each show contestant if they are willing to trade in the prize won to that point for a chance to play the BIG DEAL (selects one of three numbered doors on the stage). The process continues until a show contestant agrees to play.
- Trip Winner prize awards:
 - If a Trip Winner's associated show contestant reveals a ZONK, the Trip Winner wins \$1,000.
 - If a Trip Winner's associated show contestant reveals a PRIZE, the Trip Winner wins \$2,000.

- Bonus Prize Opportunity: If a Trip Winner's associated show contestant is **The BIG DEAL** contestant, the Trip Winner wins an additional \$1,000.
- Value of prizes won depends on the outcome of each Trip Winner's (1-5) assigned LMAD show contestants (1-5).
- **Note:** Typically, each taping of LMAD features no fewer than eight (8) contestants in each episode. There have never been fewer than five (5) contestants in an episode. In the unlikely event that there are less than five (5) contestants, the corresponding Trip Winner(s) will win \$1,000.

II. **\$5,000 Cash Prize:** During each Drawing, the Lottery will select four (4) winners of \$5,000. A total of twenty (20) \$5,000 Cash Prizes will be awarded during the Promotion.

Estimated prize value: \$5,000

CLAIMING:

Winners will be advised, at the time of notification, of claiming procedures and reminded of claiming deadlines. Claiming deadlines for winners and Alternates are included in the **Drawings Chart** above.

You do not need to keep your original ticket in order to claim your prize. (Players and winners are sometimes referred to as "you" and "your".)

If a winner has been disqualified, or by the relevant claiming deadline has not claimed, submitted all required documentation and information, and been confirmed and validated as eligible, then an Alternate may be selected. Alternates must claim by 4:30 PM on the claiming deadline designated for that Alternate. A decision to replace a winner is within the sole discretion and judgement of the Maryland Lottery. Once the decision to proceed with an Alternate is made, the person who was previously selected as a winner is no longer entitled to the prize.

You do not have the option to request or receive a substitute or equivalent prize for any prize.

Trip Prize:

Winners must claim their prize in person, unless specified by the Lottery upon notification, by **4:30 PM of the claiming deadline date listed in the Drawings Chart**, at the Maryland Lottery Baltimore Customer Resource Center, Montgomery Park Business Center, 1800 Washington Boulevard, Suite 330, Baltimore, MD 21230.

Alchemy3, LLC ("Alchemy") will fulfill the Trip Prize. After a Trip Winner is verified by the Lottery, the Lottery shall notify Alchemy, thereby initiating the trip package fulfillment process. Alchemy shall contact each Trip Winner within ten (10) business days to begin making travel arrangements. Each Trip Winner must confirm his or her trip within ten (10) days of Alchemy's contact.

Alchemy will send the spending money allowance via mail to the Trip Winner in the form of a check 30 days prior to the departure date. Alchemy will provide the Trip Winner with the check and W-2G for the cash portion that is won during the Let's Make a Deal Cash Prize Giveaway.

As a further bonus, the Lottery will pay the required estimated State and Federal tax withholdings for the Trip Prize. Further amounts may be owed by the Trip Winner, and if so, such amount(s) shall be paid by the Trip Winner. The payment of tax withholdings could result in additional Federal and State tax liability being due for the Trip Winner. All amounts paid to the Trip Winner on the Trip Winner's behalf will be included in the Trip Winner's reportable income.

Trip Winner is responsible for all taxes, including income taxes in excess of withholdings paid by the Lottery. The Trip Winner will be provided with a W-2G by the Lottery.

Unless otherwise specified by the Lottery, if a Trip Winner fails to arrive for the scheduled flight or fails to check into the arrival meet point, the Trip Winner shall forfeit the flight and/or portion of the trip package and right to participate in the studio taping of Let's Make a Deal and VIP tour and no costs will be refunded.

In the event of a winner's death or inability to partake of the Trip Prize, the Lottery will make a determination about the awarding of the Trip Prize. The Lottery's decision will be final. The Trip Winner may not choose to receive the cash equivalent of the trip portion of the Trip Prize.

\$5,000 Cash Prize:

Cash Prize winners may claim their prize in person at the Maryland Lottery Customer Resource Center, (address above), or by mail, fax, or email (with a claim form and required documentation) using the same mailing address (the Lottery will provide an email address and/or fac number upon request).

All amounts paid to you or on your behalf will be included in your reportable income. You will be taxed on those amounts. All winners are responsible for all taxes, including income taxes. You will receive a W-2G form from the Maryland Lottery for any prize won with a value greater than \$600.
