



**Maryland Lottery® My Lottery Rewards™
Royal Farms® Free Gas* Giveaway Second-Chance Promotion
DRAWING RULES**

OVERVIEW:

Beginning any time on Monday, May 5, 2025 until 11:59:59 PM Eastern Time (“ET”) on Monday, June 30, 2025 (“Promotion Period”), players can enter \$10 Mega Millions® tickets purchased at participating Royal Farms® locations into the My Lottery Rewards™ Royal Farms® Free Gas* Giveaway Second-Chance Promotion (“Promotion”) offered by the Maryland State Lottery and Gaming Control Agency (“Lottery”). Players have the chance to win up to \$1,500 in Royal Farms® gift cards (“Gift Card(s)”) (“Prize(s)”). Gift Cards can be used towards gas and other merchandise at Royal Farms® locations, but may not be used to purchase Lottery products. A series of eight (8) drawings (“Drawing(s)”) will be held throughout the Promotion to award a total of 70 prizes worth an estimated \$23,000. See below for more information.

****All prizes will be awarded as Royal Farms® Gift Cards, which may be used to purchase gas or any other items available at Royal Farms® locations, Lottery products excluded.***

HOW TO PARTICIPATE:

To participate, players can enter through the Lottery website, mdlottery.com/royalfarms, or through the My Lottery Rewards (“MLR”) website, mdlottery.com/rewards, or through the MLR app. In order to enter, participants can submit winning or non-winning single Mega Millions tickets of \$10 value or higher purchased during the Promotion Period from a Maryland Royal Farms® location (“Ticket(s)”). For each \$10 purchase increment, up to \$299 on a single Mega Millions ticket, the player will receive one (1) entry into the Promotion (“Entry”; “Entries”). For example, one (1) \$10 Mega Millions ticket equals one (1) Entry; one (1) \$20 Mega Millions ticket equals two (2) Entries; one (1) \$30 Mega Millions ticket equals three (3) Entries, etc. For each single ticket purchase of \$300 or more, the player will receive 50 Entries. Remainders after \$10 increments on each Ticket do not aggregate in the player’s account for additional Entries. Multiple ticket values cannot be combined to equal an Entry.

Entries are cumulative and will be carried over after each drawing, unless selected as a winning Entry. Entries must be entered for a specific Drawing by 11:59:59 PM ET on the announced Drawing Entry Deadline to be eligible for that Drawing. In these Royal Farms® Free Gas* Giveaway Second Chance Promotion Drawing Rules (“Rules”), all times are Eastern Time. See the **Drawings Chart** below for Drawing Number, Drawing Entry Deadline, Drawings Date, Number of Winners and Prizes for each Drawing.

Internet access and a valid email address are required to enter this Promotion and each Drawing. Mailed entries will not be accepted. Players may enter a Drawing as often as they would like, however, they may only win once during the entire Promotion; and, only one (1) Winner per household/residence address (as registered with MLR at the time of the Drawing) is permitted per Promotion. Only Tickets purchased at Maryland Royal Farms® locations and entered during the Promotion Period are valid Entries. For second-chance Drawings, players do not need to keep

the original Ticket(s) in order to claim a Prize. A Ticket may only be used to enter one (1) time. To enter and to win, you must be 18 years of age or older.

PRIZES:

- Grand Prize - \$1,500 Royal Farms® Gift Card – Two (2) winners will be selected during Drawing #8 to each receive \$1,500 worth of Royal Farms® gift cards, in the form of three (3) \$500 Royal Farms® gift cards.
- Midway Grand Prize - \$1,000 Royal Farms® Gift Card – Four (4) winners will be selected during Drawing #4 to receive \$1,000 worth of Royal Farms® gift cards, in the form of two (2) \$500 Royal Farms® gift cards.

CLAIMING:

Players will be advised, at the time of notification, of claiming procedures and claiming deadlines. Claiming deadlines for winners, including any possible Alternates, are listed below.

If a player owes any State Obligations, which include but are not limited to child support and/or certain other obligations to a State agency or other governmental entity, then the player must pay those outstanding State Obligations in order for the prize to be awarded to the player. If any of those outstanding State Obligations are not paid off within five (5) business days of claiming the prize, then the player will be disqualified, and an Alternate may be selected.

The Lottery will provide a W-2G to each Midway Grand Prize and Grand Prize winner. All amounts paid to the Winner or on the Winner's behalf will be included in the Winner's reportable income. The Winner will be taxed on those amounts. All Winners are responsible for all taxes, including income taxes.

- **Weekly Prize** – Winners will be contacted by a Lottery representative via email, telephone and/or mail to confirm their mailing address. This prize will then be automatically fulfilled by Scientific Games, LLC ("SG").

If a Winner has been disqualified, failed to claim the Prize by the applicable claiming deadline, failed to submit all required documentation and information, or otherwise has not been confirmed and validated as eligible, an Alternate may be selected. Alternates must claim by **4:30 PM** on the respective claiming deadline date designated for Alternates.

Winners do not have the option to request or receive a substitute or equivalent prize for any Prize.

A Winner's name, when claiming the Prize, must match the name listed on the internet entry.

ADDITIONAL RULES:

If any discrepancy should exist between these Rules and any other material describing this Promotion or anything related thereto, these Rules shall prevail.
