



## Maryland Lottery® My Lottery Rewards™ High's Free Gas\* Giveaway Second-Chance Promotion

### DRAWING RULES

#### OVERVIEW:

Beginning any time on Monday, July 7, 2025 until 11:59:59 PM Eastern Time ("ET") on Monday, August 25, 2025 ("Promotion Period"), players can enter \$10 worth of Multi-Match tickets purchased at participating High's of Baltimore, LLC ("High's") locations into the My Lottery Rewards™ High's Free Gas\* Giveaway Second-Chance Promotion ("Promotion") offered by the Maryland State Lottery and Gaming Control Agency ("Lottery"). Players have the chance to win \$250, \$1,000, or \$1,500 in High's Gift Cards ("Gift Card(s)") ("Prize(s)"). Gift Cards can be used towards gas and other merchandise at High's locations, but may not be used to purchase Lottery or tobacco products. A series of seven (7) weekly drawings ("Drawing(s)") will be held throughout the Promotion to award a total of 31 prizes worth an estimated \$11,000. See below for more information.

*\*All prizes will be awarded as High's gift cards, which may be used to purchase gas or any other items available at High's locations, Lottery and tobacco products excluded.*

#### HOW TO PARTICIPATE:

To participate, players can enter through the Lottery website, [mdlottery.com/highsfreegas](https://mdlottery.com/highsfreegas), the My Lottery Rewards ("MLR") website, [mdlottery.com/rewards](https://mdlottery.com/rewards), or through the MLR app. In order to enter, participants can submit \$10 worth of winning or non-winning Multi-Match tickets purchased during the Promotion Period from a participating High's location in Maryland ("Ticket(s)"). For every \$10 worth of eligible Multi-Match tickets entered, the player will receive one (1) entry into the Promotion ("Entry(ies)"). Multiple Tickets may be combined to equal \$10 and receive one (1) entry. Remainders after \$10 increments on Tickets will aggregate in players' accounts to be added to the next eligible Multi-Match ticket entry. Each Ticket may only be entered on time. Entries are cumulative and will be carried over after each drawing, unless selected as a winning Entry. Entries must be entered for a specific Drawing by 11:59:59 PM ET on the announced Drawing Entry Deadline to be eligible for that Drawing. In these High's Free Gas\* Giveaway Second-Chance Promotion Drawing Rules ("Rules"), all times are Eastern Time. See the **Drawings Chart** below for Drawing Number, Drawing Entry Deadline, Drawings Date, Number of Winners and Prizes for each Drawing.

Internet access and a valid email address are required to enter this Promotion and each Drawing. Mailed entries will not be accepted. Players may enter a Drawing as often as they would like, however, they may only win once during the entire Promotion; and, only one (1) Winner per household/residence address (as registered with MLR at the time of the Drawing) is permitted per Drawing. Only Tickets purchased at High's locations in Maryland and entered during the Promotion Period are valid Entries. For second-chance Drawings, players do not need to keep

the original Ticket(s) in order to claim a Prize. A Ticket may only be used to enter one (1) time. To enter and to win, you must be 18 years of age or older.

### **PRIZES:**

- Grand Prize - \$1,500 High's Gift Card – Two (2) winners will be selected during Drawing #7 to each receive \$1,500 worth of High's gift cards, in the form of three (3) High's gift cards loaded with the maximum amount of \$500 for each card.
- Midway Grand Prize - \$1,000 High's Gift Card – One (1) winner will be selected during Drawing #4 to receive \$1,000 worth of High's gift cards, in the form of two (2) High's gift cards loaded with the maximum amount of \$500 for each card.
- Weekly Prize - \$250 High's Gift Card – During each Drawing, four (4) winners will be selected to each receive one (1) \$250 High's gift card. There will be a total of 28 Weekly Prize winners selected.

***High's gift cards may be used for gas as well as other merchandise at High's locations, but may not be used to purchase Lottery or tobacco products.***

### **CLAIMING:**

Players will be advised, at the time of notification, of claiming procedures and claiming deadlines. Claiming deadlines for winners, including any possible Alternates, are listed below.

- **Grand Prize and Midway Grand Prize** – Winners must claim their Prize in person by **4:30 PM** on the claiming deadline listed below at the Lottery's Baltimore Customer Resource Center, Montgomery Park Business Center, 1800 Washington Boulevard, Suite 330, Baltimore, MD 21230.

If a player owes any State Obligations, which include but are not limited to child support and/or certain other obligations to a State agency or other governmental entity, then the player must pay those outstanding State Obligations in order for the prize to be awarded to the player. If any of those outstanding State Obligations are not paid off within five (5) business days of claiming the prize, then the player will be disqualified, and an Alternate may be selected. If a Winner has been disqualified, failed to claim the Prize by the applicable claiming deadline, failed to submit all required documentation and information, or otherwise has not been confirmed and validated as eligible, an Alternate may be selected. Alternates must claim by **4:30 PM** on the respective claiming deadline date designated for Alternates.

The Lottery will provide a W-2G to each Midway Grand Prize and Grand Prize winner. All amounts paid to the Winner or on the Winner's behalf will be included in the Winner's reportable income. The Winner will be taxed on those amounts. All Winners are responsible for all taxes, including income taxes.

- **Weekly Prize** – Winners will be contacted by a Lottery representative via email, telephone and/or mail to confirm their mailing address as it appears in their MLR account. This prize will then be mailed to the winner by Scientific Games, LLC ("SG"). To avoid delays, players should make certain their mailing address and contact information listed in their MLR account is up to date and accurate.

Winners do not have the option to request or receive a substitute or equivalent prize for any Prize.

A Winner's name, when claiming the Prize, must match the name listed on the internet entry.

#### **ADDITIONAL RULES:**

If any discrepancy should exist between these Rules and any other material describing this Promotion or anything related thereto, these Rules shall prevail.

All aspects of this Promotion are governed by these Rules and any amendments thereto.
