CLAIMING DEADLINE: Thursday, September 11, 2025 by 4:30 PM ET

Alternate: Friday, September 26, 2025 by 4:30 PM ET

ESTIMATED TOTAL PRIZE VALUE: VIP UMD Gameday Experience: \$580

On-Field Game Cash: \$2,000 - \$100,000 (depending on gameplay)

EVENT DATE & LOCATION: The On-Field game will take place during the University of Maryland ("UMD") vs. University of Nebraska ("UN") football game, at the University of Maryland, College Park, on **Saturday, October 11, 2025** at a time to be determined.

PRIZE DETAILS:

- I. <u>VIP UMD Gameday Experience:</u> One (1) winner will be selected as a contestant to participate in the Maryland Lottery's On-Field Game at UMD to win cash prizes between \$2,000 and \$100,000. The winner will receive:
 - two (2) suite tickets to the UN at UMD football game on Saturday, October 11, 2025,
 - parking for the day of the game,
 - \$150 spending money, and
 - participation in the On-Field Game to win a cash prize
- II. On-Field Game Cash: One contestant will play a match-and-win game where they will select from a number of boards and win the cash prize amounts revealed on those boards. The On-Field Game will consist of a possibility of two (2) rounds of play (if the contestant is able to advance past Round 1).
 - Game Play:

• Round 1:

- Contestant will choose two (2) boards from the possible ten (10) boards that are presented. Two (2) boards have Round 2 icons and \$2,500 cash prizes; eight (8) boards have cash prize amounts, ranging from \$1,000 to \$2,000.
- If the contestant reveals the two (2) boards with Round 2 icons, they will advance to Round 2. The contestant will not win any cash prize from Round 1.

• If the contestant reveals two (2) boards with monetary cash prize amounts (or only one (1) board with the Round 2 icon and one (1) board with a cash prize amount), then they win the total cash prize amounts shown on the two (2) boards. They do not advance to Round 2.

• Round 2:

• If the contestant advances to Round 2, they will have the opportunity to choose one (1) board from five (5) boards presented. Each of the five (5) boards will have cash prize amounts, ranging from \$25,000 - \$100,000. The contestant will win the cash prize amount that is revealed on the one (1) board that they selected.

CLAIMING:

The Winner will be advised at the time of notification of claiming procedures and Event procedures and Event time, as well as reminded of claiming deadlines. Winners must present proof of social security number, furnish a photo I.D., and proof of being at least 18 years of age. The Winner's guest must also be at least 18 years of age.

An Alternate may be selected if the Winner: (a) has been disqualified; or (b) by the relevant claiming deadline, has not claimed the prize, submitted all required documentation and information (including a waiver), and been confirmed and validated as eligible. A decision to replace the Winner with an Alternate is within the sole discretion and judgment of the Maryland Lottery. Once the decision to proceed with an Alternate is made, the person who was previously selected as the Winner is no longer entitled to the prize. Alternates must claim by 4:30 PM on the Alternate claiming deadline and follow the same procedure as outlined below for the Winner.

To be validated, the Winner must:

- 1) Present proof of social security number, furnish photo I.D., and proof of being at least 18 years of age;
- 2) Complete and sign a Waiver and Release of Liability. Winner must be at least 18 years old; and,
- 3) Satisfy all open State obligations (such as child support and certain other obligations to a State agency or other governmental entity) by paying all open State obligations within five (5) days of claiming the prize.

If the Winner fails to satisfy all open State obligations, the following actions may be taken:

- a. <u>Winner</u>. The Winner may decline the prize and sign a "Refusal of Prize and Waiver and Release of all Liability" form, after which an Alternate may be selected; or
- b. <u>Maryland Lottery</u>. If the Winner fails to satisfy all open State Obligations within five (5) business days of claiming the prize, the Maryland Lottery will disqualify the Winner and an Alternate will be selected. See MLR Terms of Use (link provided below) for further provisions.

The Winner must be present at the Event to win any cash prizes, however, the Winner may designate a Proxy to participate in the On-Field Game in their place if they are physically unable to attend or participate.

The Maryland Lottery will process all cash prizes within fifteen (15) business days of the Event. The Winner will receive a W-2G form from the Maryland Lottery. The Winner is responsible to satisfy all taxes, including income tax, associated with all prizes won.

In the event of a Winner's death or other inability to claim the prize, the Maryland Lottery will make a determination about the awarding of the prize. This decision will be final. Winner does not have the option to request or receive a substitute or equivalent prize for any prize.
