



**Maryland Lottery® My Lottery Rewards™**  
**Unlock the Cash Live Game Second-Chance Promotion**  
**Drawing Rules**

**OVERVIEW:**

Beginning any time on Friday, August 22, 2025, until 11:59:59 PM Eastern Time (“ET”) on Wednesday, November 5, 2025 (“Promotion Period”), players can enter the Maryland Lottery® My Lottery Rewards™ Unlock the Cash Live Game Second-Chance Promotion (“Promotion”) offered by the Maryland State Lottery and Gaming Control Agency (“Lottery” or “Maryland Lottery”) for a chance to be invited to Lottery headquarters to play the Unlock the Cash Live Game (“Live Game”) and win cash prizes. The Lottery will conduct a series of three (3) second-chance drawings (“Drawing(s)”) throughout the Promotion to select six (6) winners to participate in the Live Game and win total cash prizes ranging from \$5,000 to \$25,000.

**PRIZE DESCRIPTIONS:**

Six winners will be invited to Lottery headquarters in Baltimore to play the Unlock the Cash Live Game for the chance to win total cash prizes between \$5,000 and \$25,000. Two winners at a time will be scheduled to play the Live Game. During the Live Game, the two winners will each have the opportunity to unlock two safes out of six available safes and win the prizes revealed. The six (6) available prizes include: \$2,500 (x2), \$2,500 + \$5 Scratch-Offs valued at \$300 (x2), \$10,000 (x1), and \$15,000 (x1). Each winner will randomly select two safes and win the prize inside.

**HOW TO ENTER:**

To participate, enter at [mdlottery.com/unlockthecash](https://mdlottery.com/unlockthecash), through My Lottery Rewards (“MLR”) at [mdlottery.com/rewards](https://mdlottery.com/rewards), or through the MLR App, \$10 worth of non-winning Maryland Lottery® Break the Bank Scratch-Off tickets (game #761), and/or winning or non-winning FAST PLAY Cash Combination tickets, and/or any other ticket specified by the Lottery (“Ticket(s)”), in any combination, during the Promotion Period. A player does not need to enter \$10 worth of Tickets all at the same time/during the same session. Eligible Ticket values will aggregate in the players account to generate one (1) entry into the Promotion once the \$10 threshold is reached. Entries are cumulative and will carry over after each Drawing to the next one unless selected as a winning entry.

**FOR EACH DRAWING:**

Entries must be entered for a specific Drawing by 11:59:59 PM Eastern Time on the announced Drawing Entry Deadline date to be eligible for that Drawing. (In these Rules, all times are Eastern Time.) Entries are cumulative and will be carried over after each drawing to the next one unless selected as a winning entry. **See the Drawing Chart below for Drawing Number, Drawing Start Date, Drawing Entry Deadlines, Drawing Dates, Number of Winners, Prizes, and Claiming Deadlines.**

Players may enter as often as they would like, however,

- a player may only win once during the entire Promotion; and
- only one winner per household (as registered in My Lottery Rewards) is allowed per Drawing.

You do not need to keep your original Tickets to claim your prize if you win. (Players and Winners are sometimes referred to as “you” and “your”.) A qualifying entry is \$10 worth of Tickets. A Ticket may only be used to enter one time. To enter and to win, you must be 18 years of age or older.

**All winners, including alternate winners (“Alternates” or “Alternate”), must claim your prize by 3:30 PM on the respective claiming deadline dates shown above.**

#### **CLAIMING:**

Winners will be advised, at the time of notification, of claiming procedures and reminded of claiming deadlines. Claiming deadlines for Winners, including Alternates, are included in the chart above.

- Winners must claim their prize by 3:30 PM of the claiming deadline date and as otherwise described within.
- If a player owes State Obligations, which include but are not limited to child support and certain other obligations to a State agency or other governmental entity, then the jackpot prize will be applied first to their unpaid State Obligations. The player will be taxed on those amounts.
- If a winner has been disqualified, or by the relevant claiming deadline has not claimed, submitted all required documentation and information, and been confirmed and validated as eligible, then an Alternate winner may be selected. Alternates must claim by 4:30 PM of the claiming deadline date designated for Alternates.
- You do not have the option to request or receive a substitute or equivalent prize for any prize.

Once the Winner has claimed their prize:

- Lottery staff will work with Winners to schedule a date and time to play the Live Game at the Maryland Lottery Customer Resource Center, Montgomery Park Business Center, 1800 Washington Boulevard, Suite 330, Baltimore, MD 21230.
- Winner must be present during the Live Game in order to participate and to win a prize. However, a Winner may choose to designate a Proxy to participate in their place in the event that they are unable to physically participate or attend the Live Game. Winners and Proxies must be at least 18 years old.
- The Live Game will be recorded by the Lottery. The video recording will be used for internal auditing purposes and any video footage or pictures may be used for promotional purposes, such as being

featured on the Lottery's website and social media pages. Winners and Proxies do not have the option to remain anonymous. The Winners and Proxies will be requested to complete a publicity agreement.

- Winners must allow 15 business days for delivery of their prize won during the Live Game.
- Winners will be provided with a W-2G form. All amounts paid to the Winner or on the Winner's behalf will be included in the Winner's reportable income. The Winner will be taxed on all amounts paid. All Winners are responsible for all taxes, including income taxes.
