



**Maryland Lottery® My Lottery Rewards™**  
**JURASSIC PARK Second-Chance Promotion**  
**Drawing Rules**

**OVERVIEW:**

Beginning any time on Friday, September 19, 2025, until 11:59:59 PM on Tuesday, January 6, 2026, ("Promotion Period") players can enter the JURASSIC PARK Second-Chance Promotion ("Promotion") offered by the Maryland State Lottery and Gaming Control Agency ("Maryland Lottery" or "Lottery") through Maryland Lottery® My Lottery Rewards™ ("MLR") for the chance to win one (1) of four (4) trips for two (2) to Hawaii, to participate in the \$1,000,000 JACKPOT CHALLENGE ("CHALLENGE"), on or about November 2026 ("Trip Prize"), for a chance to win up to \$1 million in cash prizes. This Promotion will consist of four (4) drawings ("Drawing(s)"), and the Lottery will select one (1) winner ("Prizewinner") of the Trip Prize during each drawing.

**HOW TO PARTICIPATE:**

Enter at [mdlottery.com/jurassicpark](https://mdlottery.com/jurassicpark) or [mdlottery.com/rewards](https://mdlottery.com/rewards) or through the **MLR App**, non-winning JURASSIC PARK Scratch-Off tickets and/or any other ticket specified by the Lottery, purchased during the Promotion Period (each a "Ticket"). Each Ticket entered will generate a variable, randomly-determined number of entries into the Promotion. Players may receive five (5), ten (10), fifteen (15), twenty (20), or twenty-five (25) entries per Ticket entered. The number of entries to which a Ticket is entitled is random and determined at the time of Ticket entry into MLR.

When a Ticket is entered into MLR, an animated interactive promotional game ("Promotional Game") will appear on the player's screen and reveal the number of entries the player will receive into the Promotion. Players may choose to bypass the Promotional Game and directly reveal the number of entries their Ticket will generate. A player's performance on the Promotional Game has no impact on the number of entries the player receives for each Ticket.

A Ticket may only be used once to enter the Promotion. Players will automatically receive progress toward active MLR achievements as well as the variable, randomly-determined number of entries into the Promotion for each Ticket entered.

Entries are not cumulative and will not carry over from each drawing to the next. Entries must be entered by 11:59:59 PM on the announced Drawing Entry Deadline date in order to be eligible for that Drawing. (In these Drawing Rules, all times are Eastern Time ("ET").) See the **Drawings Chart** below for Drawing Number, Drawing Entry Start Date, Drawing Entry Deadline Date, Drawing Date, and Claiming Deadline Date for Prizewinners and alternate Prizewinners ("Alternate(s)", and "Alt.").

**All Prizewinners, including Alternates, must claim their prize by 4:30 PM EST on the respective claiming deadline. All entries received after the final Drawing Entry Deadline Date will be ineligible and void.**

A Drawing may include any random selection event. This is a bonus drawing, and the Trip Prize is a bonus prize.

Internet access and a valid email address are required for entry into the Promotion and its Drawings. Mailed entries will not be accepted.

To enter and to win, players must be 18 years of age or older.

Players may enter the Promotion as many times as they want, however

- players may only win one (1) time during the entire Promotion; and
- only one (1) Prizewinner per household/residence address (as registered with MLR at the time of the Drawing) is permitted throughout the Promotion.

All Prizewinners' names and town/city of residence will be posted on the My Lottery Rewards Past Drawings & Winners page, and the Maryland Lottery Promotions page, and may be included in the Maryland Lottery's press releases, promotional emails, and/or social media posts.

#### **PRIZE DESCRIPTION:**

Each Prizewinner will receive one (1) trip prize ("Trip Prize") package with event participation in the \$1,000,000 JACKPOT CHALLENGE Event ("CHALLENGE"). The Trip Prize is a six-day and five-night trip for the Prizewinner and one (1) guest to Hawaii to take place on or around November 2026.

The Trip Prize will include:

- Roundtrip coach class airfare for up to two (2) people from a U.S. international airport to Daniel K. Inouye International Airport in Honolulu, Hawaii (inclusive of all associated security fees, taxes, and surcharges);
- Ground transfers between destination airport and the destination hotel and, if necessary, between contractor ("SG") hosted activities and events;
- One (1) double occupancy room accommodations (room and room tax only) at a 3-star or better hotel in Oahu, Hawaii for five (5) nights;
- One thousand dollars (\$1,000) spending money for the Prizewinner to be provided two (2) weeks prior to the scheduled trip departure date;
- Admission for the Prizewinner and guest to the Welcome Reception;
- Prizewinner shall select one (1) tour or excursion from a variety of curated tours and activities in and around Oahu for Prizewinner and guest;
- Admission to the CHALLENGE Event venue for the Prizewinner and guest;
- The Prizewinner, or duly authorized proxy, shall have one (1) chance to participate in the CHALLENGE for a chance to win up to one million dollars (\$1,000,000) as described below. The Prizewinner's guest may sit with the Prizewinner but will not be eligible to be a participant in the CHALLENGE unless the guest has been appointed as the Prizewinner's proxy.

Estimated Trip Prize value: \$14,895.83 (this total includes estimated tax withholdings and does not include any potential Cash Prizes).

The Trip Prize does **not** include personal expenses including but not limited to: mileage, insurance, gratuities, meals, parking fees, baggage fees, alcoholic beverages, personal expenses such as telephone calls, valet service, laundry, incidentals and the like, revision or cancellation fees that may be charged by the hotel or other suppliers, or any other items not expressly specified herein.

The Prizewinner or guest must have a valid credit card or shall be required to post cash deposit for incidentals to check into the hotel. The Prizewinner and guest must be eighteen (18) years of age or older to participate in the CHALLENGE. Each Prizewinner and guest are subject to a background investigation, derived from public information, prior to the CHALLENGE.

Prizewinner and guest shall be required to comply with the Department of Homeland Security's ("DHS") REAL ID Act and all other programs to attend the CHALLENGE. For more information, please see [DHS's REAL ID webpage](#). If applicable, Prizewinner and guest shall be required to follow all health and safety protocols as instructed by the event's staff and volunteers and all federal, state, and local guidelines.

Trip Prizes are not for resale and are not transferable. The Prizewinner may **not** choose to receive the cash equivalent of the trip portion of the Trip Prize.

Failure to comply with any of the official Promotion and/or CHALLENGE Details, Promotion and/or Event and Security Procedures, any other guidelines, or codes of conduct set forth by SG, may result in a Contestant's disqualification at SG's sole and absolute discretion and/or the revocation of any Cash Prize won during the CHALLENGE.

If the Prizewinner is unable to physically participate in the CHALLENGE, they may designate a Proxy. The Prizewinner may designate their guest to be their Proxy. The selection of the Proxy must be duly approved by the Lottery and the Contractor.

If the Prizewinner fails to appear at the designated time of and place of flight departure (excluding flight delays), or fails to check in to the hotel when they arrive in Hawaii, or fails to arrive for their scheduled participation in the CHALLENGE, or is determined to be unable to attend the trip after the trip has been booked, the Contractor will appoint a proxy to participate in the CHALLENGE for the Prizewinner, and the Prizewinner shall receive any prizes won by the proxy (less applicable tax withholdings).

### **\$1,000,000 JACKPOT CHALLENGE EVENT DETAILS:**

**Overview:** The CHALLENGE shall be conducted according to Event and Security Procedures generated by SG and its third-party underwriters. Final official event details (the "CHALLENGE Details") explaining how the CHALLENGE will be conducted will be provided to the Maryland Lottery no later than 120 days prior to the date of the CHALLENGE.

Each Prizewinner (or assigned proxy) shall participate as a contestant ("Contestant") in the CHALLENGE together with Contestants from other participating lottery jurisdictions. The CHALLENGE consists of one (1) event. Each Contestant will participate in the CHALLENGE in a series of mini games for the chance to win cash prizes ("Challenge Prizes").

Each Contestant will have one (1) chance to play a series of mini games for the chance to win cash prizes (collectively, the "Challenge Prize"). The total potential Challenge Prize that may be won by each Contestant, shall be based upon the round (defined below) in which the Contestant is participating,

and will range from one thousand dollars (\$1,000) up to a chance to win one million dollars (\$1,000,000) ("Grand Prize"). The total Challenge Prize won, less tax withholdings, in the CHALLENGE by the Prizewinner will be mailed to the Prizewinner within thirty (30) business days after the official conclusion of the EVENT, but no later than December 31, 2026.

The CHALLENGE will consist of four (4) round ("Round(s)"). Each Round will be played separately as follows:

- i. **Round 1:** Cash Prizes range from seventy-five dollars (\$75) up to one thousand dollars (\$1,000).
- ii. **Round 2:** Cash Prizes range from one hundred dollars (\$100) up to five thousand dollars (\$5,000).
- iii. **Round 3:** Cash Prizes range from five hundred dollars (\$500) up to fifty thousand dollars (\$50,000).
- iv. **Round 4:** Cash Prizes range from three hundred twenty-five dollars (\$325) up to one million dollars (\$1,000,000).

**Additional Conditions:**

Prizewinners will be mailed the Event Details concerning the CHALLENGE prior to their Trip Prize departure.

SG reserves the right to modify specific game play provided such change does not result in a lower expected payout for the Contestant for the modified portion.

All CHALLENGE Rounds will be audited by an third-party auditor.

The CHALLENGE is being administered by SG. Any questions regarding the CHALLENGE, including questions regarding the assignment of proxies, Challenge Prize payments, and tax liability or withholding for Challenge Prizes, should be directed to SG at 1-800-201-0108. Participation in the CHALLENGE may be subject to other local, state and federal laws, including the laws of the State of Hawaii.

Universal Studios Licensing LLC ("Universal") and the Amblin Entertainment, Inc. ("Amblin"), each of their parents and/or any of their subsidiaries, affiliates or licensors (Universal, Amblin, and each of their parents, subsidiaries, affiliates, and licensors are collectively referred to hereinafter as, the "Universal Entities") and are not sponsors or administrators of the CHALLENGE.

All Challenge Prizes in the CHALLENGE are underwritten by either SG, third party, or both. Challenge Prizes are not considered won by the Contestant, and are not payable unless and until the third party underwriter (the "Risk Counterparty Representatives") of such Challenge Prize payouts and SG's Event Official certify that the CHALLENGE has been conducted appropriately and in accordance with the official Event and Security Procedures, that a Contestant has validly won the Challenge Prize award pursuant to the official CHALLENGE Details and the Prizewinner is entitled to receive the Challenge Prize. The Risk Counterparty Representative will then be required to pay the Challenge Prize to the Prizewinners. The Maryland Lottery, and other participating lotteries, shall have no liability for any Challenge Prize amounts awarded collectively in the CHALLENGE.

All Challenge Prizes won by the Contestants will be subject to the Maryland Lottery's debt setoff procedures.

Challenge Prizes of one million dollars (\$1,000,000) are awarded as a lump sum payment to the Prizewinner, less tax withholdings.

**CLAIMING:**

Winners will be advised, at the time of notification, of claiming procedures and reminded of claiming deadlines. Claiming deadlines for winners and Alternates are included in the **Drawings Chart** above. Winners must claim their prize in person, unless specified by the Lottery upon notification, by **4:30 PM of the claiming deadline date listed in the Drawings Chart**, at the Maryland Lottery Baltimore Customer Resource Center, Montgomery Park Business Center, 1800 Washington Boulevard, Suite 330, Baltimore, MD 21230. The Trip Prize will be fulfilled by SG, once authorized by the Lottery, and the fulfillment shall include the scheduling and coordination of all travel, hotel accommodation, and ground transfers.

The Prizewinner will be mailed the CHALLENGE Details prior to their trip departure. The one thousand dollars (\$1,000) spending money will be awarded as a check and be mailed to the Prizewinner from Scientific Games, LLC ("SG" or "Contractor") two (2) weeks prior to the commencement of his or her trip in the Prizewinner's final travel packet via signature required method. If the Prizewinner has debt set-off, the Prizewinner will receive the amount less the debt owed. If the debt owed exceeds one thousand dollars (\$1,000), the Prizewinner has the option to pay the debt or to forfeit the Trip Prize. The Lottery will then select an Alternate to replace the original Prizewinner.

If a Prizewinner has been disqualified, or by the relevant claiming deadline has not claimed, submitted all required documentation and information, and been confirmed and validated as eligible, then an Alternate may be selected. Alternates must claim by 4:30 PM on the claiming deadline designated for that Alternate. A decision to replace a winner is within the sole discretion and judgement of the Maryland Lottery. Once the decision to proceed with an Alternate is made, the person who was previously selected as a winner is no longer entitled to the prize.

SG will pay the required estimated State and Federal tax withholdings for the Trip Prize and the Challenge Prizes awarded during the CHALLENGE, and the Prizewinner will be provided with a W-2G by January 31, 2027 for tax year 2026. Further amounts may be owed by the Prizewinner, and if so, such amount(s) shall be paid by the Prizewinner. The payment of tax withholdings could result in additional Federal and State tax liability being due for the Prizewinner. All amounts paid to the Prizewinner on the Prizewinner's behalf will be included in the Prizewinner's reportable income. Prizewinner is responsible for all taxes, including income taxes in excess of withholdings paid by the SG. The total amount of Prizes won during the CHALLENGE by the Prizewinner, less the tax withholdings, will be paid to the Prizewinner by SG within 30 business days after the official conclusion of the Event in Hawaii, but not later than December 31, 2026.

If a Prizewinner:

- a. Is traveling via air and fails to appear at the designated time of and place of departure (excluding flight delays), Contractor will use reasonable efforts to reschedule the flight at the expense of the Prizewinner. If Contractor is not able to reschedule the flight, then the Trip Prize shall be forfeited with the exception of the one thousand dollars (\$1,000) spending money portion of the Trip Prize, less any tax withholdings; however, Contractor will appoint a proxy to participate in the CHALLENGE for the Prizewinner, and the Prizewinner shall receive any prizes won by the proxy (less applicable tax withholdings). Contractor assigned proxies are selected from a pool of off-duty EMS workers, firefighters and police personnel hired for the CHALLENGE;
- b. Fails to check in to the hotel when he or she arrives in Hawaii, Contractor will use reasonable efforts to reschedule the reservation at the Prizewinner's expense. If Contractor is unable to

reschedule the reservation, the balance of the trip portion of the Trip Prize shall be forfeited with the exception of the return air travel and one thousand dollars (\$1,000) spending money portion of the Trip Prize, less any tax withholdings; however, Contractor will appoint a proxy to participate in the CHALLENGE for the Prizewinner, and the Prizewinner shall receive any prizes won by the proxy (less applicable tax withholdings);

- c. Fails to arrive for his or her scheduled participation in the CHALLENGE, the Prizewinner forfeits the right to personally participate in the CHALLENGE as a Contestant; however, Contractor will appoint a proxy to participate in the CHALLENGE for the Prizewinner, and the Prizewinner shall receive any Prizes won by the proxy (less applicable tax withholdings);
- d. Is determined to be unable to attend the trip after the trip has been booked, the balance of the Trip Prize shall be forfeited with the exception of the one thousand dollars (\$1,000) spending money portion of the Trip Prize, less any tax withholdings; however, the Lottery or Contractor will appoint a proxy to participate in the CHALLENGE for the Prizewinner, and the Prizewinner shall receive any Prizes won by the proxy (less applicable tax withholdings)

In the event of a winner's death or inability to partake of the Trip Prize, the Lottery will make a determination about the awarding of the Trip Prize. The Lottery's decision will be final. The Prizewinner may not choose to receive the cash equivalent of the trip portion of the Trip Prize.

Should any of the dates of the CHALLENGE change due to a Force Majeure event, Contractor shall work with the Prizewinner(s) and the Lottery and use its best efforts to reschedule the fulfillment of the Trip Prize described above in accordance with the new CHALLENGE schedule or offer a comparable prize.

#### **MISCELLANEOUS:**

The Maryland State Lottery and Gaming Control Agency, Scientific Games, LLC ("SG"), and Universal Entities are not responsible to entrants or to any other person for data entry errors resulting from or caused by the entering, keying or mis-keying of the required ticket information by entrants.

An entrant hereby releases the State of Maryland, the Maryland State Lottery and Gaming Control Agency, SG, and Universal Entities (collectively "Released Parties") and all of its agents and employees from any and all liability or claims arising from participation in the Promotion. Entrants assume all known and unknown risks in connection therewith. An entrant agrees that they will never prosecute or in any way aid in prosecuting any demand, claim or suit against the State of Maryland, its agent, or any of their agents and employees for any loss, damage or injury to their person or property that may occur from any cause whatsoever as a result of their taking part in the Promotion.

In addition to those included in the Terms of Use, the following may not participate in the Promotion or its Drawings: any officer or employee of SG nor Universal Entities; and/or any member or such officer or employee's immediate family (spouse, child, parent, parent-in-law, or sibling) who resides in the same residence as the officer or employee.
