**TRIP PRIZE DETAILS:**

**Two-Night Getaway to Rock Hall, Maryland**

- For two people (Winner plus one guest);
- Hotel accommodations: 3 days / 2 nights at The Inn at Osprey Point in Rock Hall, Maryland with daily breakfast, portorage, and all taxes and gratuities included; and
- Sailing Cruise: A 3-hour sailing cruise on the Chesapeake Bay.

**CLAIMING:**

Winner will be advised, at the time of notification, of claiming procedures and reminded of claiming deadlines.

An Alternate may be selected if the Winner: (a) has been disqualified; or (b) by the relevant claiming deadline, has not claimed the Trip Prize, submitted all required documentation and information (including waivers for both the Winner and guest), and been validated as eligible. A decision to replace the Winner with an Alternate is within the sole discretion and judgment of the Maryland Lottery. Once the decision to proceed with an Alternate is made, the person who was previously selected as the Winner is no longer entitled to the Trip Prize. Alternates must claim by 4:30 PM on the Alternate claiming deadline and follow the same procedure as outlined below for the Winner.

To be validated, the Winner must:

- 1) Appear in person at the Maryland Lottery’s Baltimore Customer Resource Center located at Montgomery Park Business Center, 1800 Washington Boulevard, Suite 330, Baltimore, MD 21230 to claim the Trip Prize; and,
- 2) Complete and sign a Waiver and Release of Liability. Both Winner and Guest must be at least 18 years old and either Winner or Guest must be at least 21 years old. Winner’s identified guest (“Guest”) must also complete and sign a Waiver and Release of Liability. If Guest does not

accompany Winner when Trip Prize is initially claimed, Guest may sign the Waiver separately. Additional waivers may be required as determined and provided to the Winner by SG; and,

- 3) Satisfy all open State Obligations (such as child support and certain other obligations to a State agency or other governmental entity) by paying all open State Obligations within 5 days of in-person claiming the Trip Prize.

If the Winner fails to satisfy all open State Obligations, the following actions may be taken:

- a. Winner. The Winner may decline the Trip Prize and sign a “Refusal of Prize and Waiver and Release of all Liability” form, after which an Alternate may be selected; or
- b. Maryland Lottery. If the Winner fails to satisfy all open State Obligations within five (5) business days of appearing in person to claim the Trip Prize, the Maryland Lottery will disqualify the Winner and an Alternate may be selected. See MLR Terms of Use (link provided below) for further provisions.

Once the Winner has properly claimed the Trip Prize and been validated by the Maryland Lottery, the Maryland Lottery will forward the Winner’s information to Scientific Games, LLC (formerly Scientific Games International, Inc. as identified in the Official Rules) (“SG”). SG will provide the Winner with a detailed Registration Package containing all travel rules and guidelines. The Winner is solely responsible for booking all Trip Prize-related travel (i.e., hotel, flights, excursions, etc.) a minimum of sixty (60) days prior to the date of the preferred departure date. All bookings are based on availability at the time of booking.

The Trip Prize must be completed by June 29, 2027.

In the event of a Winner’s death or other inability to complete the Trip Prize, the Maryland Lottery will make a determination about the awarding of the Trip Prize. This decision will be final. Winner does not have the option to request or receive a substitute or equivalent prize for any Trip Prize.
