



**Maryland Lottery® My Lottery Rewards™
Ms.PAC-MAN™ Second-Chance Promotion**

Drawing Rules

OVERVIEW:

Beginning any time on Friday, April 17, 2026, until 11:59:59 PM Eastern Time (“ET”) on Monday, June 22, 2026, players can enter the Ms. PAC-MAN™ Second-Chance Promotion (“Promotion”) offered by the Maryland State Lottery and Gaming Control Agency (“Maryland Lottery”) through My Lottery Rewards™ (“MLR”) for a chance to win cash prizes or a Ms.PAC-MAN Arcade Machine (“Prize”). A series of three (3) drawings will be conducted to select a total of seven (7) winners (“Winner”). See below for more information on prize detail and how to participate.

HOW TO PARTICIPATE:

To participate, enter through My Lottery Rewards at mdlottery.com/rewards, through the MLR App, or at mdlottery.com/ms-pac-man any non-winning Maryland Lottery® Ms.PAC-MAN Scratch-Off tickets (Game #794) or any other ticket specified by the Maryland Lottery (“Ticket”). Each Ticket entered equals one (1) entry (“Entry”) into the promotion.

Entries are cumulative and will be carried over after each drawing to the next drawing, unless selected as a winning Entry. Entries must be entered by 11:59:59 PM ET on its announced Drawing Entry Deadline date in order to be eligible for that Drawing. See the Drawing Chart below for Drawing Number, Drawing Entry Start Date, Drawing Entry Deadline, Drawing Date, and Claiming Deadline.

A Drawing may include any random selection event. This is a bonus drawing, and the Prizes are bonus prizes. To enter and to win, you must be 18 years of age or older. Internet access and a valid email address are required to enter this Promotion. Mailed entries will not be accepted. You may enter as often as you like, but:

- You may only win once during the Promotion; and
- Only one Winner per household (based on the address registered with MLR at the time of the Drawing) is allowed during the Promotion.

You do not need to keep your original Ticket to claim your Prize if you win. A Ticket may only be used to enter the Promotion one time. Players will automatically receive one (1) Entry per Ticket into the Promotion, and progress towards MLR achievements.

All Winners, including alternate Winners (“Alternate”), must claim your prize by 4:30 PM ET on the respective claiming deadline dates shown in the Drawing Chart. Entries received after the final Drawing Entry Deadline will be ineligible and void.

PRIZE DESCRIPTION:

- I. **\$5,000** – One (1) Winner will be awarded \$5,000 in the form of a check.
- II. **Ms.PAC-MAN Arcade Set** – Two (2) Winners will be awarded a Ms.PAC-MAN Arcade Set which includes:
 - one (1) Ms.PAC-MAN GALAGA Pixel Bash Edition Arcade Unit;
 - one (1) 30” Ms.PAC-MAN bar stool;
 - one (1) 3’x5’ Ms.PAC-MAN carpet; and
 - white-glove delivery service.

- III. **\$2,000** – One (1) Winner will be awarded \$2,000 in the form of a check.
- IV. **\$1,000** – One (1) Winner will be awarded \$1,000 in the form of a check.
- V. **\$700** – One (1) Winner will be awarded \$700 in the form of a check.
- VI. **\$500** – One (1) Winner will be awarded \$500 in the form of a check.

CLAIMING:

You will be advised, at the time of notification, of claiming procedures and reminded of claiming deadlines. Claiming deadlines for Winners, including Alternates, are included in the Drawing Chart above.

- Winners may claim their Prize in person at the Maryland Lottery Baltimore Customer Resource Center, 1800 Washington Boulevard, Suite 330, Baltimore, MD 21230 or by mail, fax or email (with a claim form and required documentation) using the same mailing address; An email address and/or fax number will be provided upon request.
- The Maryland Lottery will provide you a W-2G form for all Prizes except the \$500 Prize.
- If a Winner has been disqualified, or by the relevant claiming deadline has not claimed and submitted all required documentation and information, and been confirmed and validated as eligible then an Alternate may be selected. Alternates must claim by 4:30 PM ET on the respective claiming deadline designated for Alternates.
- You do not have the option to request or receive a substitute or equivalent prize for any Prize.

- If the name of the person who claims does not match the name on the Entry, then that person cannot claim and, upon validation by the person whose name is on the Entry, the prize will be awarded to the person whose name was listed on the Entry.

Fulfillment and Delivery of Ms.PAC-MAN Arcade Set

Once a Winner has claimed their prize, and the Maryland Lottery has verified the Winner's eligibility, the information provided by the Winner will be provided to Pollard Banknote Limited ("PBL") by a Communications representative. PBL will contact the Winner and provide Winner with all necessary information for fulfillment; including scheduling delivery of the Prize. The white glove service will include bringing the arcade unite into the Winner's home and potentially into the room of choice – provided a safe space/environment including a clear path, etc., removing the packaging, and plugging the unit in if requested by Winner. These arcade units are pre-built. This service does not include building pieces or assembly.

PBL and the Maryland Lottery reserve the right to substitute the merchandise prizing for equal or greater value items.

All amounts paid to you or on your behalf will be included in your reportable income. You will be taxed on those amounts. All Winners are responsible for all taxes, including income taxes.
