



**Maryland Lottery® My Lottery Rewards™
NASCAR Powerball The Chase™ Second-Chance Promotion**

DRAWING RULES

OVERVIEW:

Beginning any time on Monday, May 4, 2026, until 11:59:59 PM Eastern Time (“ET”) on Monday, June 15, 2026, (“Promotion Period”) players can enter the Maryland Lottery® My Lottery Rewards™ NASCAR Powerball The Chase™ Second-Chance Promotion (“Promotion”) offered by the Maryland State Lottery and Gaming Control Agency (“Maryland Lottery”) for a chance to win \$2,500 and be selected as Maryland Lottery’s Finalist (“Maryland Finalist”) to participate in the NASCAR Powerball The Chase™ Promotion (“The Chase Drawings”), held by the Multi-State Lottery Association (“MUSL”). The Maryland Finalist will be entered into the national The Chase Drawings for a chance to win cash prizes up to \$1 million and a VIP trip to Homestead-Miami for the 2026 NASCAR Cup Series Championship Race™ in November 2026.

The Promotion will consist of six (6) drawings (“Drawing(s)”). The Maryland Lottery will select a total of forty (40) winners (“Winner(s)”) in Drawings 1 through 5. In Draw 6, one (1) Maryland Finalist will be selected from the pool of 40 Winners to participate in The Chase Drawings.

The Chase Drawings will consist of four (4) drawings throughout the NASCAR Cup Series season during which Finalists from all participating states will win cash prizes starting at \$2,000. Four (4) Finalists in The Chase Drawings will win a VIP Trip to Homestead-Miami for the 2026 NASCAR Cup Series Championship Race™ where one (1) Finalist will win the grand prize of \$1,000,000 and the other three (3) finalist will win \$10,000 each.

HOW TO PARTICIPATE:

Enter through mdlottery.com/promotion/nascar-powerball-the-chase, the [MLR website](#), or through the MLR App, both winning and non-winning Powerball® tickets, of any price, purchased during the Promotion Period (“Ticket(s)”). Players will have the opportunity to elect or refuse participation in this Promotion. Each Ticket entered into the program will trigger a pop-up on the website and app that will require the member to choose if they want to enter into the Promotion, or if they want to decline entry into the Promotion. Each Ticket will gain a member one (1) entry into the Promotion when the member elects to participate. Additionally, each Ticket will gain a member progress toward active MLR Achievements whether they elect to participate in the Promotion or not.

FOR EACH DRAWING:

Entries are non-cumulative, and will not carry over after each Drawing. Entries must be entered for a specific Drawing by 11:59:59 PM ET on the announced drawing entry deadline date to be eligible for that Drawing. See the Drawing Chart below for Drawing Number, Drawing Entry Deadlines, Drawing Dates, Number of Winners, Prizes, and Claiming Deadlines.

Internet access and a valid email address are required to create a My Lottery Rewards account and enter this Promotion. Mailed entries will not be accepted. You may enter as often as you like, and:

- You may only win one time throughout the Promotion; and
- Only one player per household/residence address (as registered with MLR at the time of the Drawing) is allowed to win per Drawing.

You do not need to keep your Ticket in order to claim your prize if you win.

To enter, you must be 18 years of age or older. All winners must be at least 18 years of age.

All Winners' names and town/city of residence will be posted on the My Lottery Rewards Past Drawings & Winners and the Maryland Lottery Promotions pages, and the Maryland Finalist will be announced nationally. The Maryland Finalist proceeding to The Chase Drawings will be required to sign name and image release forms from NBC and NASCAR®.

All winners, including alternate winners ("Alternates" or "Alternate"), must claim their prize by 4:30 PM on the respective claiming deadline date shown above.

PRIZES:

- I. For Drawings No. 1-5, each of the forty (40) Winners will receive:
 - \$2,500 in the form of a check; and
 - Entry into the final drawing for the Maryland Finalist who will proceed to participate in MUSL's national NASCAR Powerball The Chase™ Promotion for the chance to win a VIP

trip for two (2) to Homestead-Miami for the 2026 NASCAR Cup Series Championship™ in November, 2026.

- II. For Drawing No. 6, one (1) Winner will be selected to become the Maryland Finalist in MUSL’s national NASCAR Powerball The Chase™ Promotion. All state Finalists will participate in MUSL’s national drawings for the opportunity to win cash between \$2,000 and \$1 million, as well as a VIP Trip for two (2) to the 2026 NASCAR Cup Series Championship™ in November, 2026. <u>VIP Trip Prize:</u>				
Four Finalists will be selected during MUSL’s Drawing 4 to win The VIP Trip Prize to Miami, FL, from approximately Friday, November 6, 2026 to Monday, November 9, 2026, to participate in MUSL’s Drawing 4 for cash prizes of \$10,000 and \$1,000,000. MUSL’s Drawing 4 will be conducted on Sunday, November 8, 2026, during the live television broadcast of the NASCAR Cup Series Championship™ Race on NBC (“Program”) from Homestead-Miami Speedway, Homestead, FL. Each Finalist may select one (1) guest (“Guest”) to participate in				

the VIP Trip Prize only (not the \$1 million prize). The VIP Trip Prize approximate value is \$10,000 and may include the following or like elements:

- Round-trip, coach-class airline transportation for two (2) people from the major airport nearest Finalist’s city to Miami, FL (if within 250 miles of Miami, FL, rail or ground transportation to be substituted);
- Three (3) nights hotel accommodations (selected by MUSL or its vendor (“Prize Provider”) in its sole discretion) in Florida (double occupancy, room and tax only);
- Two (2) Ally Pit Box at Homestead passes (includes food, beverages and Infield Experience access) at Homestead-Miami Speedway for admission to:
 - NASCAR O’Reilly Auto Parts Series Championship™ Race on Saturday, November 7, 2026;
 - NASCAR Cup Series Championship Race™ on Sunday, November 8, 2026;
- Two (2) passes for VIP Experiences at Homestead-Miami Speedway during NASCAR Championship Weekend™ for Saturday, November 7 and Sunday, November 8, 2026 including:
 - NASCAR Cup Series™ garage pass
 - NASCAR team hauler tour
 - MRN Radio booth tour
 - Pace car rides
 - Pre-Race attendance
 - Victory Lane access
- Two (2) official NASCAR Championship Weekend™ Event Programs;
- Two (2) Souvenir Gift Bags, each with a retail value of at least two hundred fifty dollars (\$250);
- All meals while in Florida; and
- Ground transportation to and from airports, hotel, and activities in Florida.

Finalists are not required to travel to Florida to participate in the drawing for, and remain eligible to win, the \$1 million prize. Finalists may appoint a proxy and provide contact information for the proxy on or before October 22, 2026 to take the trip instead, subject to the Trip Prize Terms and Conditions, but will still remain eligible to win the \$1 million prize.

- Finalist (or their proxy) may also have the opportunity to participate in the recording and production of the Program and/or appear in the Broadcast of the Program, provided that Finalist completes and signs all required releases and clear the background check in order to take the trip. In the event that Finalist’s designated proxy does not clear the background check, the Prize Provider reserves the right, in its sole discretion, either to (i) allow Finalist to appoint another proxy to take the trip (subject to background clearance and Prize Provider deadlines); or (ii) allow proxy to travel and to appoint a second proxy (selected by Prize Provider) to participate in the Program.

- For the avoidance of doubt, Finalist's eligibility to participate in the trip and/or the drawing for the \$1 million prize is not affected by Finalist's failure to complete and sign all required release and forms and/or to consent to a background check and/or by any information obtained pursuant to a background check, but those failures may affect the nature of his/her appearance and/or degree of participation in the Program. While Finalist's eligibility to participate in the drawing for the \$1 million prize is an element of the Trip Prize, the opportunity to participate in the recording and production of the Program and/or appear in the broadcast of the Program is expressly NOT an element of the Trip Prize and is determined by Prize Provider in its sole discretion. Prize Provider reserves the right to appoint a proxy to appear and participate in the Program for Finalist for any reason as it may determine in its sole discretion. The appointment of any proxy shall not affect Finalist's eligibility for the \$1 million prize.

CLAIMING:

You will be advised, at the time of notification, of claiming procedures and reminded of claiming deadlines. Claiming deadlines for Winners, including Alternates, are included in the Drawing Chart.

- Winners must allow 30 business days after the Lottery receives a claim for delivery of your prize.
- If a winner has been disqualified, or by the relevant claiming deadline has not claimed, submitted all required documentation and information and been confirmed and validated as eligible, then an Alternate Winner may be selected. Alternates must claim by 4:30 PM of the claiming deadline designated for Alternates. A decision to replace a Winner with an Alternate is within the sole discretion and judgment of the Maryland Lottery. Once the decision to proceed with an Alternate is made, the person who was previously selected as a Winner is no longer entitled to a prize.
- You do not have the option to request or receive a substitute or equivalent prize for any prize.

National semi-finalists and finalists are subject to the full amount of any taxes due on the total value of the VIP Trip Prize and the other tiers of cash prizes, as well as the \$1 million prize. Maryland Lottery will pay the required estimated State and Federal tax withholdings for the VIP Trip Prize, and other tiers of cash prizes, as well as the \$1 million prize in the event that the Maryland Finalist is selected as the \$1 million prize winner. Further amounts may be owed by the Winner, and if so, such amount(s) shall be paid by the Winner. The payment of tax withholdings could result in additional Federal and State tax liability being due for the Winner. All amounts paid to you or on your behalf will be included in your reportable income. You will be taxes on those amounts. The Winner is responsible for all taxes, including income taxes in excess of withholdings paid by the Lottery. MUSL does not withhold or remit income taxes on behalf of prize winners, all prizes are awarded by lotteries, just like Powerball prizes. MUSL will wire prize money to appropriate lotteries after the public announcement of each The Chase Drawing. VIP Trip Prize winners will incur a tax liability based on the value of the trip.
