DRAWING RULES

ENTRY DATES: Monday, July 6, 2026 at 00:00:00 AM Eastern Time ("ET")
to Monday, July 27, 2026 at 11:59:59 PM ET

DRAWING DATE: Tuesday, July 28, 2026

CLAIMING DEADLINE: Friday, August 14, 2026 by 4:30 PM
Alternate: Friday, August 21, 2026 by 4:30 PM

POINTS REQUIRED FOR ENTRY: Fifty (50) Draw Points

NO. OF WINNERS: Ten (10)

ESTIMATED TOTAL PRIZE VALUE: Maryland State Fair Event Tickets – \$90
Event Game Cash – \$1,000 - \$20,225

EVENT DATE & LOCATION: Saturday, September 5, 2026 at the Maryland State Fairgrounds at a time to be determined ("Event"). Winners will be notified of the time by a Maryland Lottery representative.

PRIZE DETAILS:

1. Event Tickets: Each Winner will receive:

- Five (5) general admission Maryland State Fair tickets; and
- One (1) parking pass for the day of the Event on Saturday, September 5, 2026.
- Winners who attend the Event will be eligible to participate in Event games. A Winner may designate a proxy to attend the Event in their place.

2. Event Game Cash:

- Winners who attend the Event ("Attending Winners") will be eligible to participate in a single round of Event games.
- *Event Round 1: Oversized Game Board* – The ten (10) Attending Winners will each peel an oversized game board to reveal their prizes.
 - Five (5) Attending Winners will reveal \$1,000 prizes and be eliminated from further play; and
 - Five (5) Attending Winners will move on to Round 2.
- *Event Round 2: Cooler* – The remaining five (5) Attending Winners will each open a Lottery branded cooler to reveal their prizes.
 - Three (3) Attending Winners will reveal \$5,000 prizes and be eliminated from further play and get to keep the cooler (estimated value: \$225); and
 - Two (2) Attending Winners will move on to the Final Round and get to keep the cooler (estimated value: \$225).

- *Final Round: Prize Drop* – The remaining two (2) Attending Winners will each drop a disc two times on a board to collect the prize amounts on which the discs land. Each Winner can win up to \$20,000.

CLAIMING:

Each Winner will be notified and advised of claiming and Event procedures as well as reminded of claiming deadlines.

An Alternate may be selected if a Winner: (a) has been disqualified; or (b) by the relevant claiming deadline, has not claimed the Maryland State Fair Event Tickets prize, submitted all required documentation and information (including a waiver), and been confirmed and validated as eligible. A decision to replace the Winner with an Alternate is within the sole discretion and judgment of the Maryland Lottery. Once the decision to proceed with an Alternate is made, the person who was previously selected as the Winner is no longer entitled to the Event Tickets prize. Alternates must claim by 4:30 PM on the Alternate claiming deadline and follow the same procedure as outlined below for the Winner.

To be validated, a Winner must:

- 1) Appear in person, or designate a proxy to appear on their behalf, at the Maryland Lottery's Baltimore Customer Resource Center located at Montgomery Park Business Center, 1800 Washington Boulevard, Suite 330, Baltimore, MD 21230 to claim the Maryland State Fair Event Ticket prize; and,
- 2) Complete and sign a Waiver and Release of Liability. Winners must be at least 18 years old; and,
- 3) Satisfy all open State Obligations (such as child support and certain other obligations to a State agency or other governmental entity) by paying all open State Obligations within 5 days of in-person claiming the Maryland State Fair Event Ticket prize.

If a Winner fails to satisfy all open State Obligations, the following actions may be taken:

- a. Winner. The Winner may decline the Maryland State Fair Event Ticket prize and sign a "Refusal of Prize and Waiver and Release of all Liability" form, after which an Alternate may be selected; or
- b. Maryland Lottery. If the Winner fails to satisfy all open State Obligations within five (5) business days of appearing in person to claim the Trip Prize, the Maryland Lottery will disqualify the Winner and an Alternate may be selected. See MLR Terms of Use (link provided below) for further provisions.

The Maryland Lottery will process all cash prizes within 30 business days of the Event. Winners will each receive a W-2G form from the Maryland Lottery. Winners are responsible to satisfy all taxes, including income tax, associated with all prizes won.

In the event of a Winner's death or other inability to complete the Maryland State Fair Event Ticket prize, the Maryland Lottery will make a determination about the awarding of the Maryland State Fair Event Ticket prize. This decision will be final. Winner does not have the option to request or receive a substitute or equivalent prize for any Maryland State Fair Event Ticket prize.
